January 7 <sup>th</sup> :	Introduction's, description of what will be required, question and answer period, presentation of materials to trainees, start shore side training.

January 21 <sup>st</sup> :	Question/Answer period and review of tasks covered in Jan. 7 <sup>th</sup> class, reviewed the sign off booklets of all trainee's present to see if they completed homework assignment, presentation of new materials through powerpoint and hands on training, continued shore side training.

February 4 <sup>th</sup> :	Question/Answer period and review of tasks previously covered in the first two training sessions. Instructors presented new training materials through powerpoint and hands on training. Continued shore side training and started testing trainees on what they have learned to date. Sign-offs were started for trainee's that showed proficiency in Tasks that have been previously demonstrated and practiced. Trainees and an Instructor from Flotilla 04-03 have joined our class.

February 18 <sup>th</sup> :	Question/Answer period and review of tasks previously covered in the first three training sessions. After all questions were answered, Navigation training was started. Instructors introduced the trainees to various charts of the Division 4 AOR (incl: 1210TR), various nautical tools used in plotting, and had trainees plot at least 2 three-leg courses. Trainees were also introduced and instructed on the use of the Time-Speed-Distance formula. After Navigation training, instructors worked with trainees on line work to reinforce what they have learned previously and aid in their retention of the tasks. Sign-offs were started for trainee's that showed proficiency in Tasks that have been previously demonstrated and practiced.

March 3<sup>rd</sup>: Quizzed trainees on the Phonetic Alphabet by reciting their first & last names. Then held question/answer period and review of tasks previously covered. All questions were answered and the second part of the Navigation training was started. Instructors worked with all trainees on what was covered during the last Navigation class, and additional Navigation training was conducted in how to locate points on a chart by using GPS coordinates and vice versa. In addition basic underway topics and concepts were discussed and reviewed. After navigation training was completed. Instructors worked with trainees and ran them through a "VIRTUAL" Boat Crew Patrol from arrival at the launching area to the end of patrol. This included, Coxswain/Crew/Trainee facility assignments, pre-underway checklist, GAR form, setting up the facility for getting underway, getting underway, watch standing assignments and their duties, radio communications, things encountered during patrols and what to look out for, difference between a heading and a bearing, calling out objects/vessels on the water, anchoring drills, man overboard drills, and securing from patrols for the evening. Tows were not covered during this class due to time restrictions. Some sign-offs were conducted.
