We attended public affair events. 3 members attended Hooked on Hudson – Renée, Joyce and I. Rio marched in the St. Patrick's Day parade. We did security details. Alan helped the Coast Guard at the bike tour. 4 members helped the Coast Guard at the New York Marathon – Alan, Joyce, Jim L. and Jim D'Amore. We did member training in 2015. We had four members take the TCO class – Jim L, Jim D, Alan and Sean. We had 2 members become crew qualified – Alan and Jim L. (Ed. Note.: We also had Jim D. begin crew training).

River Quality in Bergen, Passaic, Hudson Counties

Are the local waters clean? In a canoe or kayak, you get wet. There is spray that you taste, and paddle drippings all over your arms. On a warm nice day, in clean, fast moving water, (like cresting little waves, center of Hudson, windward) this is great. But with kids in the canoe, you have to step up and make sure the water is clean. And how about fishing, can you eat them?

<u>Wildlife</u>. Without dispute, our rivers and lakes (Hackensack, Passaic, Hudson Rivers, and Overpeck Creek) have been remarkably quick to rebound over the last 3-4 decades since most major industrial discharges ended, and landfills were capped and closed. Proof is seen in birds. As the Hackensack Riverkeeper regularly reports, the birds are a bellwether to the river's ecological health, and in the Meadowlands, the species have numbered in the hundreds and are ever growing.

The return of the bald eagle on Overpeck Creek (Hackensack tributary in Bergen County) is proof enough, experienced personally. Lately, one of their nests are cordoned off. With chicks in the nest, the giant bald eagle will circle you 100 feet above, warning and defending.

Eating Fish. The NJ EPA measures waterways for safe consumption levels. In Hudson River below the Battery, one can eat 1 winter flounder per month, but only 4 white perches per *year*. In Overpeck Creek, Ridgefield Park, general population can eat 4 largemouth bass per year, but high risk population may consume 0. Perhaps our *catch and eat* fishing should be in places like Monksville Reservoir near Greenwood Lake, or Rockland Lake, in New York.

Skin Contact. I have observed on many occasions, the Hackensack River in the Teaneck / River Edge areas, causes minor skin irritation on contact. This is somewhat less so in center river, in Secaucus. Maybe the abundant tall grasses clean the water, and wide flow and wind churning help. Overpeck Creek is cleaner yet. It is spring fed from the clean hills of Englewood, Tenafly, and Teaneck, passing by minimal industrial pollution. Cut off from the Hackensack River by a tidewall, it is abutted by tree and grass capped municipal landfills, closed for many decades. Our Flotilla enjoyed its beauty during last year's paddle event.

In sum, the future will surely only bring cleaner waters to our local waterways. In the meantime, enjoy responsibly.


