CIB erosion project a true team effort Editor:

The Center for the Inland Bays (CIB) recently completed a significant project to prevent the erosion, and to expand the habitat, of a portion of the land strip that runs along the Bethany Loop Canal.

The project required the installation of some 100 logs into the Salt Pond, and using 500 stakes and 2,000 feet of hemp rope to keep the logs in place. Installation was performed by: Darryl Duffie of the Mosquito Control Section of DNREC; and CIB staff members and volunteers — Marianne Walch, Jonathan Forte, Dave Ritondo, Mike Read, Larry Hutson, Martha Redmond and Ramon Vasquez.

Two Bethany Beach residents played significant roles on this project. Bob Collins, a CIB employee and a resident of Lake Bethany, was responsible for the entire implementation. He also installed 27 coir fiber logs along the Strip. Chuck Peterson, a resident of Tingles Addition and a member of the Bethany Beach Town Council, worked for two-plus years with CIB and Tingles Addition neighbors to clarify the problem and the solution. He also helped Bob install and tie down the 27 coir fiber logs.

I'm most appreciative of the implementation efforts made by all. And I especially want to thank Bob Collins and Chuck Peterson for their significant efforts that made this implementation a reality.
