#### The USCG Mobile App

The USCG mobile app has been available for a few years now and yet many people may not know about it or use it. It is available for both Ios and Android phones and has all the features for boating safety in one place.



These features include: Safe Boating Information, Request a Safety Check, Review Safety Equipment, File Float Plan, Rules of the Road, NOAA Buoys, Report a Hazard, Report Pollution, Reporting Suspicious Activity and an icon for Emergency Assistance.

You can set up a profile that will let you enter the information for your vessel(s).

Please take a minute and request a Safety Check of your vessel to see if our Flotilla vessel examiners are assigned correctly to the 20 mile radius of our area.

## Focus On .... 12-01 Member Fran Doyle, IPFC, FSO-VE
