- **Capt. Richard Etheridge**, the first African-American to command a Life-Saving station when he was appointed as keeper of the Pea Island Life-Saving Station on January 24, 1880

... but we still have work to do to make our service more representative of American society. To do that, we have to plant the seeds of diversity and opportunity as an operational imperative, which ultimately results in improved performance, decisionmaking quality and collaboration.

Diversity is representation. Inclusion is fostering belonging and opportunity. We must attract, retain, and inspire a diverse workforce.



#### USCG AUX CS TEAM ALERT FROM HOMELAND SECURITY

Microsoft has announced a critical vulnerability in their Windows 10 operating system that can potentially be exploited to undermine trust across the system and other software. This flaw allows threat actors to bypass security tools by spoofing legitimate digital signatures. New vulnerabilities are continually emerging, but the best defense against attackers exploiting vulnerabilities is simple: keep software up to date. Timely patching is one of the most efficient and cost-effective steps an organization or an individual can take to minimize exposure to cybersecurity threats.

As a Department we are rapidly patching all affected Windows systems and recommend you do the same on your home windows-based computers using the Windows update feature. In Windows 10, Windows Update is found within Settings. To get there, select the Start menu, followed by the settings icon (picture of a "gear") to the left. In there, choose Update & Security and then Windows Update on the left. Check for new Windows 10 updates by choosing Check for updates and follow the instructions on the screen. If not set already, we recommend you configure your home computers and other devices for automatic updates so that you never have to manually do it.

#### 2020 NATIONAL OPERATIONS WORKSHOPS

Ref: Auxiliary Manual, COMDTINST M16790.1 (series), section 8.B.1.g

1. The 2020 Surface Operations Workshop is required for all boat crew coxswains, boat crew members, personal water craft operators, paddle craft operators, and associated trainees.

2. This workshop must be completed by June 30th, 2020. Those who fail to complete the workshop by the deadline will not be authorized to be assigned to duty to perform surface operations patrols or activities and will be placed in Required Workshop Not Met (REWK) status. Those placed in REWK status will have until December 31st, 2020 to complete the workshop without further consequence to their competency certification status. 3. The 2020 Air Operations and Telecommunications workshops are optional. Those members certified or training to become certified in aviation and telecommunications competencies are strongly encouraged to complete their respective program workshop.

4. These workshops may be delivered by any Auxiliarist qualified in the respective operations program as long as they are either a certified instructor or are under the supervision of a certified instructor.

5. Internet Release Authorized.

#### COAST GUARD COMMISSIONS CUTTER DANIEL TARR

# Cutter named for USCG coxswain who servedduring the amphibious invasion of Tulagi, SolomonIslands, in 1942USCG, January 12, 2020

The Coast Guard held a commissioning ceremony for the Coast Guard Cutter *Daniel Tarr*, the service's 36th fast response cutter, at Sector Field Office Galveston, Texas, Friday

Vice Adm. Scott Buschman, Coast Guard Atlantic Area commander, presided over the ceremony, along with Rear Adm. John Nadeau, Eighth Coast Guard District commander, and Lt. Nicholas Martin, Coast Guard Cutter Daniel Tarr commanding officer.

Daniel Tarr, the cutter's namesake, was one of four Coast Guard coxswains who served with the Marines during the amphibious invasion of Tulagi, Solomon Islands, in August 1942. Tarr enlisted as a surfman and later became coxswain of USS McKean's Boat Number 1 prior to the invasion. On Aug. 7, 1942, Tarr, along with the other three coxswains, landed the first wave of the Marine Corps' Raider Battalion on the beaches of Tulagi; in the following three days, they also delivered vitally needed equipment, ammunition and supplies. For their role in the landing of the Marines' first wave, and capture of Tulagi, the four coxswains were awarded the Silver Star Medal. They were the first enlisted men in the Coast Guard to receive the Silver Star Medal.

The Coast Guard Cutter *Daniel Tarr*'s patrol area will encompass 900 miles of coastline for the Coast Guard's Eighth District, from Carrabelle, Florida, to Brownsville, Texas. Fast response cutters are named after Coast Guard enlisted heroes and will replace the service's 110-foot patrol boats. These vessels feature advanced command, control, communications, computers, intelligence, surveillance and reconnaissance equipment.

#### HANJ MAPPING



CHANJ is a strategic plan for wildlife conservation that identifies key areas and the actions needed to preserve

and restore habitat connectivity for our terrestrial wildlife. The <u>CHANJ Web Viewer</u> is easy to use from your computer or mobile device, and it's a seriously cool tool to see where we all -- land managers, transportation planners, conservation groups, and the public -- can support wildlife habitat connectivity across New Jersey.



Where do *you* stand in NJ's connectivity puzzle? Type an address, town, or place into the "Find address" bar to get started. Or click the "My Location" button (compass) on the left side of your screen to zoom right in to your current location.

The large *Core* habitats (green) and potential wildlife movement *Corridors* (yellow-brown) shown in the CHANJ mapping are important areas to preserve or restore land. *Road Segments* that cut through those habitats (shown as bold grey-black lines) are likely to pose barriers or danger areas for animals and may be considered "opportunities" for mitigation.

Remember, our <u>Guidance Document</u> can help you interpret the mapping and prioritize actions.


