

## BRIDGE TALK



ello fellow members, this is my final contribution to the ADVOCATE Newsletter as your Flotilla Commander. Let me say first that Carole and I both wish you and your loved ones the very best that these holidays have to offer. Enjoy your families and friends and stay warm and safe.

Please accept my heart felt thanks for all your hard work this year in maintaining Flotilla 3-10's status as one of the most productive flotilla's in the District.

#### In 2016, Flotilla 3-10 members, performed:

- Joe Riley Flotilla Commander 3-10
  - 446 Vessel Safety Checks aboard boats in the water, on lifts, and on trailers throughout our wide geographical area of operation. This was an increase of 40 % over 2015's level of 311 VSC's. It was almost 70% more than in 2014.
  - 543 Program Visits involving travel to and from widely separated Partners in 7 counties in the Northern Neck and Middle Peninsula of Virginia. This was an increase of 79% over 2015 Visits. It was more than double the 2014's visits.
  - Six (6) Public and 5 Private boating safety education classes for 856 students in 5 counties of the Northern Neck and Middle Peninsula. The number of public students in 2016 was an increase of 31 (20%) over 2015 levels. It was an increase of 95 public students or 150% over 2014 levels. The number of Kids 'n Water students was 600 more than each previous year!!
  - 76 patrol missions involving more than 425 individual underway hours. This included the verification of 77 Federal and Private Aids to Navigation. The Operations program is the only mission area that showed a decline rather than an increase over the past two years. Notwithstanding, we met every Coast Guard demand in our traditional AOR and several beyond.

Congratulations and thanks to George Edward Gray, Jr and Andris ("Andy") Baltins who were sworn in as FC and VFC respectively for 2017 by Amy Thomas, DCDR, at The Inn at Montross. Ed and Andy are committed to the awesome challenge of carrying on the legacy of excellence that has been the hallmark of Flotilla 3-10 since its inception. Their team of dedicated Staff Officers will play an important role in that challenge. Just as will every member -- as always.

Our Change of Watch is a time honored opportunity for members past and present and supporting partners to join together during the holiday season to both participate in the long tradition of transfer of authority and responsibility of elected officers and celebrate the holiday season with fellow ship-mates. It is a time for coming together to celebrate one year and envision yet another - our 40th - of sincere commitment to the core values of the Auxiliary.

It has been a privilege to have served the members of Flotilla 3-10 over the past two years. The Honor, Respect, and Devotion to Duty demonstrated by our members have been in keeping with the highest traditions of the United States Coast Guard and the United States Coast Guard Auxiliary.

#### **Belly Bust**

I hope the many friendly folks in the Chesapeake Bay area will help Julianne Laird find a suitable "paddling community" [*Mail Call*, Oct 2016]. 1 hope they might also share their understanding/expertise of how to wear an inflatable life jacket.

The inflatable life jacket that Ms. Laird is pictured wearing appears to be a belly-pack device which she is wearing as a fanny-pack. If she reaches back and pulls it ("jerk to inflate"), she will have the wrong end aimed toward the air. It needs to be on the front. When opened, these things literally explode full. They are horseshoe shaped like a Type 2 and have to be pulled over the head and tied together after inflation.

It would be a shame for other readers to use Ms. Laird's "fanny pack" method as a role model.

I have attached a picture that demonstrates why the proper place to wear the inflatable bag is as a belly pack. These are demonstrated by Gary Palsgrove, another Boating Safety Instructor. Gary has inflated the belly pack inflatable for hundreds of boating safety students over the past several years.

#### MARINA FIRE



HENRICO, Va. (AP) -- Authorities say a fire at a Virginia marina has destroyed about a dozen boats. No injuries have been reported.

T he fire broke out Friday December 9th morning at the Richmond Yacht Basin along the James River in Henrico County, which surrounds the capital of Richmond.

Fire Capt. Taylor Goodman says the blaze destroyed 12 to 15 boats and caused part of a building to collapse at the marina. Goodman says a neighbor reported the fire about 7 a.m. and alerted people who were staying on their boats.

Marina president Max Walraven said late Friday morning that some of the burning vessels drifted down the river and some sunk.

It's not yet clear what started the fire.

**FIRE** strikes fear into the hearts and minds of boaters because it always occurs suddenly and unexpected, and far too often is deadly.

We should use this article as a reminder that when we speak to boaters that we meet at local marinas to advise them to choose their boat heaters carefully.

Most boats have compact areas where it is difficult to allow proper "safety" air space around heating units. There are some "boat specific" heaters that are recommended for boat applications. BoatUS is a good resource for choosing the right heater, along with their "Seaworthy" publication.

The right selection can avoid disaster.
