Giant Hogweed reportedly found in Virginia



The Massey Herbarium at Virginia Tech said in a Facebook post that 30 giant hogweed plants were discovered in Clarke County, located between Winchester and Leesburg. There have been reports from Virginia Department of Transportation (VDOT) of sightings of Giant Hogweed in the Staunton area and Middlesex County. There is a strong possibility that the Giant Hogweed could find its way into the Coastal Virginia area.



If you have never heard of Giant Hogweed, you're not alone! But, Giant Hogweed makes Poison Ivy look like a walk in the park. Skin reactions vary, but phytophotodermatitis can occur, meaning the sap makes the skin so sensitive to sunlight that severe burns can occur from normal exposure to sun. Symptoms include painful blisters, which become darkly pigmented and can cause scars. And, if the sap gets in your eyes, there is the potential for blindness.

Giant hogweed (Heracleum mantegazzianum) is an invasive herb originally brought to North America from Asia and has since become established in the New England, Mid-Atlantic, and Northwest regions of the United States. Giant hogweed grows along streams and rivers and in fields, forests, yards and roadsides, and can reach 14 feet or more in height with leaves up to 5 feet in width.



This plant is currently on the Virginia Invasive Plants Early Detection Species list - This designation means the plant is not yet widely established in Virginia but is known to be highly invasive. The Virginia Department of Conservation and Recreation investigates reports of the

plant and takes action to eradicate it to prevent permanent establishment. Its flowers resemble a giant Queen Anne's Lace weed. If you come across this plant, you can to report it but never touch it. Report sightings of invasive species here, (<u>http://www.vainvasivespecies.org/reportsightings</u>).


If someone comes into physical contact with giant hogweed, the following steps should be taken:

- Wash the affected area thoroughly with soap and COLD water as soon as possible.
- Keep the exposed area away from sunlight for 48 hours.
- If hogweed sap gets into the eyes, rinse them with water and wear sunglasses.

• See a doctor if any sign of reaction sets in.



The affected area of skin may remain sensitive to sunlight for a few years, so applying sun block and keeping the affected area shielded from the sun whenever possible are sensible precautions.
