Division 20 plans to conduct a Crew College beginning in January. The plan is to cover EVERY crew task over a period of seven, three-hour sessions. After each of the in port tasks are presented and later reviewed, there will be an opportunity for candidates to demonstrate their mastery of the skill and obtain a sign-off from one of the mentors present. Obviously, we cannot sign off any underway tasks. However, we will still cover them, so the candidates' subsequent on-the-water training can be made as efficient as possible. Dates for the training will be: Sundays 14 Jan, 21 Jan, 28 Jan, 11 Feb, 18 Feb, 25 Feb, and 4 March. All will be held from 1400-1700 at the Fairfield Harbour POA Activities Building, Room 3 (some weeks we have Room 2 in addition), 902 Coral Reef Drive, New Bern 28560. Crew candidates are welcomed to attend as many of the sessions that they want or need depending upon their experience and the existing sign-offs they already have obtained.

Wreaths Across America

On 16 December a large contingent of 20-04 members attended and participated in the Wreaths Across America ceremony held at the National Cemetery in New Bern. They were joined by active duty members from Stations Hobucken, Fort Macon and Emerald Isle, as well as Auxiliarists from 20-01 and 20-06.

Wreaths Across America is a national program recognizing fallen veterans and their families. Wreaths are placed on veterans' graves across the United States, including Arlington National Cemetery.

A moving playing of Taps preceded each uniformed service formally placing a wreath on the grave of one of the fallen. Uniformed members from across Division 20 joined their active duty compatriots in a formation led by Commander Delgado from Sector North Carolina during the ceremony and all members participated in the actual laying of wreaths on over 5,000 graves following the ceremony.

It was a very impressive and solemn event which the 20-04 participants agreed was something they would like to continue to do in the future.

Deployed by Harry "Bud" McClard



Saturday morning, August 26, 2017, my wife Carol and I were driving from New Bern to CG Station Hobucken for the annual picnic when my cell phone beeped me that I had missed a call. We were in the area where there is no cell signal. The caller ID on the phone just said "FEMA", my address book entry for the phone number that calls when we are being deployed. That call started an extraordinary adventure that no one would have expected during the course of a "normal" hurricane season.

I have been a disaster inspector working with FEMA since 2006. My background included engineering and management and a second career as a

licensed residential and commercial building inspector and general contractor. Carol retired after a career as a banking and mortgage executive in 2014 and became an inspector in 2016.

All official FEMA inspections are completed by contractors. There are two prime contractors, Vanguard Emergency Management and WSP Inspections. Both are based in and work closely with FEMA in Winchester, Virginia, to carry out the mission of providing timely inspections of disaster applications for emergency assistance under the Stafford Act. We undergo DHS security clearance and then we are issued a DHS/FEMA photo identification as first responders and the red stripe on our ID stating "Federal Emergency Response Official". The ID badge also contains an RFID chip that contains information related to our access to no-entry, quarantined, or federal facility areas. Training is partly directed by FEMA but mostly by the prime contractors and we are expected to remain current with all regulations and federal guidelines related to FEMA obligations and restrictions. I overheard a FEMA official giving an orientation to new arrivals to the Joint Field Office (JFO) in San Juan saying "The inspectors are the tip of the spear of our mission; they qualify the applicants and document the needs and then we follow up."
