## Information from the District meeting in Williamsburg

I attended the District meeting in Williamsburg on 24 and 25 September.

Elections for our 2017 district leadership were held on Saturday. Dave Adams was elected District Commodore, Michelle Thornton of Sector Hampton Roads was elected District Chief of Staff; and Bruce Johnson was once again elected Sector MD/NCR District Captain.

Issues addressed during the weekend included the need for timely and accurate unit reports, PSI backlog, completion of mandatory training, patrol accidents, paddle craft fatalities and need for training and outreach.

Suggestions for addressing mandatory training included creation of CDs for members, hands-on help with FEMA training, and adjustment of bylaws to allow quorums with fewer attendees. Commander Thacko acknowledged some older members may never complete training and need to adjust for that fact.

The upcoming award cycle was highlighted. These include Auxiliarist of the Year, Greanoff awards, Flotilla Meritorious Achievement, and Lifetime Achievement awards. Most are due by December, if not sooner.

Opportunities abound for PA and Ops in October. Sector MD/NCR is looking for Auxiliarists to train in Marine Safety specialties. Boat shows in Oct. include Annapolis Sailboat Show Oct. 6-10 and Powerboat Show Oct 14-16. Fleet Week and Blue Angels is Oct. 14-16.

Upcoming events and deadlines were stressed. The Division Election is scheduled for Oct. 06 and nominations may be made from the floor. Flotilla elections should be scheduled in November.

Budgets and financial reports/inventory reports are due in January along with annual listing of officers.

Continuing Issues in the district are Mandatory Training, PSIs and the need for timely reports



Auxiliarists can receive training and support for PQSs relevant to Sector Maryland-NCR only. (There are a limited number of Auxiliary-specific Marine Safety PQSs that are taught by Auxiliarists.)

#### **Staffing Needs**

Sector needs our help with the following:

**AUX-WM, AUX-EC, AUX-ACP, AUX-PSC** – 3-6 Auxiliarists needed in each PQS; scheduled training will be provided

**AUX-ED** – Auxiliarists are needed throughout the Sector; unscheduled training will be provided

**CFVE, AUX-UPV** – Several Eastern Shore Auxiliarists are needed; training will be offered at STA Ocean City or another Eastern Shore location **AUX-EU** – 1-2 Auxiliarists needed; scheduled

training will be provided
Sector could also use help with data entry

#### **Training Plan**

We want to identify Auxiliarists who are interested in receiving high quality training from Sector Prevention active duty personnel. Please review the following even if you do not think you're interested in the Auxiliary's Marine Safety mission:

**Nov. 2016-April 2017, twice a month** – Auxiliary Assistant Waterways Management Representative (AUX-WM) *This training would potentially be of interest to coxswains, boat crew, and ATON verifiers* 

**Nov. 2017-April 2018, twice a month** – Auxiliary Assistant Pollution Responder (AUX-ED)

There is a need for Auxiliarists throughout the sector that can be called on to check out reports of pollution spills.

As soon as possible – Commercial Fishing Vessel Examiner (CFVE) & Auxiliary Uninspected Passenger Vessel Examiner (AUX-UPV)

Sector needs several more CFVEs, particularly on the Eastern Shore. Training can be offered wherever there are enough people to make it worthwhile. **Other training** will be offered if enough people are willing to commit to the PQS. Most training will be offered on weekends or weekday evenings.

## Announcing a New Basic Qualification Course (BQC II)

A new Basic Qualification course (BQC II) is available to all members. While aimed primarily at Application Pending (AP) status members that want to rapidly move towards Basically Qualified (BQ) status, it provides information on Auxiliary missions, programs, policies and structure to better prepare all members for their service.

The Basic Qualification Course (BQC II) introduces the member to the Auxiliary Manual (AUXMAN) in 7 student study guide modules. Each module covers one or two chapters of the AUXMAN but with a major reduction in the reading required. The modules are stand alone and can be taken in any order. At the conclusion of each Module, the member takes a 22 question exam located on the National Testing Center (NTC) website. Passing the open book exam with at least 90% is recorded in AUXDATA for your permanent record. The AUXDATA record also shows up in your AUXDIR (OFFICER) profile.

The BQC II Course link can be found on the Training Directorate website. Go to the National Website at CGAUX.org, then go to the Directorate pull down menu and select "Training". In the left hand column, you will see the link to "Basic Qual II Course".

Disposal of
Unwanted/
Outdated
Pyrotechnic Devices

Auxiliarists are sometimes asked to

accept out-of-date or otherwise unwanted pyrotechnic devices disposal. Accepting such materials for disposal is not an authorized mission for the Auxiliary and may result in individual Auxiliarists taking possession of unstable and hazardous materials and becoming personally responsible for their disposal. Although some municipal and volunteer fire departments or law enforcement agencies may accept pyrotechnics for disposal, many will not. Disposal may pose potential health or safety hazards to the individual or to the environment.

If, as a member of the Coast Guard Auxiliary, you are requested to take possession of such materials for disposal, the request must be respectfully declined. The only appropriate advice that may be given with respect to disposing of the unwanted materials is to caution against throwing them overboard, activating them in the marine environment, or disposing of them in household trash.

It would be appropriate to suggest that the individual contact local law enforcement or fire protection authorities for guidance on disposing of the unwanted materials. Members should not recommend that they be activated on land or retained on board a vessel as back-ups since older flares may become unstable and their burn rates unpredictable.

#### Introducing a New Aux Weather Course

The Training Directorate is tasked with developing the next generation of Operational Specialty Courses (AUXOP) including: Weather, Communications, Seamanship, Patrols, and Navigation. We are announcing that the new Weather Specialty Course (AUXWEA) will be available mid-October 2016.

The new AUXWEA course includes the new: student study guide (SSG), PowerPoint slides (PPT), and the new AUXWEA exam on The National Testing Center Website (NTC).

The new course eliminates unnecessary complications from the description of weather phenomenon, and adds modern terminology and concepts to the class. In addition, there is a new a chapter that discusses weather from the coxswain's perspective.

Existing AUXWEA course material will be available until mid-October; after that all AUXWEA material will be converted to the new course including the NTC exam. For those instructors that teach AUXWEA and members interested in starting to study AUXWEA, we recommend waiting until mid-October for the new material to be available. Those members currently studying AUXWEA have until mid-October to complete the old exam.

#### National Training Directorate DSO-MT Teleconference Minutes

Basic Qualification Course II (BQCII) is to become mandatory for new members in 2017 to move from AP to BQ in addition to completing all the AUXMT (mandated training) courses and the Boating Safely Course. BQCII will be introduced to the membership by October 2016 for Beta Testing (that's where users find problems with the program, if there are any). There are seven modules and can be taken in any order like the AUXMT Courses. Each module has twenty exam questions at the end that will be on the National Testing Center (NTC) web portal. BQCII will also replace the Administrative Procedures Course (APC, one of the courses required for elected officer candidates). Not that many changes from what we're doing now, mostly better organization and documentation of the material.

BQCII, presumably, builds on the Basic Qualification Course and Personnel Qualification Standards (PQS) now available on-line at the National Training Directorate web page (http://wow.uscgaux.info/content.php?unit=T-

DEPT&category=basic-qualification). The course and PQS is voluntary, even though some parts of the PQS are already required. Mandated Training and National Association of Safe Boating Law Administrators (NASBLA) approved boating class, for example.

PQS includes questions to be answered correctly before a mentor as well as completion of activities and courses, similar to Boat Crew qualification process, that is:

- •ICS100 and ICS700
- Mandated Training 8 courses
- A NASBLA certified Boating Safety Course e.g. ABS, BS&S, SS&S
- ADM Papp Leadership Series Videos

• A Member Involvement Plan

It is noted that members already BQ, don't need to complete the PQS to remain BQ.

Want to move from IQ to BQ? Implementing the BQ PQS courses now is an option. Members who like the process for moving to BQ as it is should make the move to BQ now. All in all, this is a good thing for members seeking knowledge and understanding and for the Auxiliary seeking knowledgeable, informed members.

Also noted in the Training Directorate DSO-MT Teleconference Minutes is that Auxiliary Operational (AUXOP) Courses are being updated and improved, many to be issued before the end of the year.

Proctored paper exams will be eliminated – they'll be available at the NTC, still proctored – much more convenient and efficient.

A new course, AUXRESCUE to be implemented, is in it's early stages of development.

Finally, revised Flotilla and Division Procedure Guides are in revision and near release.

## New Reporting Form for Uninspected Commercial Vessels.

After many years of misreporting and for a variety of other reasons, a new form was created for the reporting of the Uninspected Commercial Vessels. This new form (the ANSC 7066 Commercial Vessel Examination Activity Report) is located on the PDF Forms for Auxiliarists page at:

http://forms.cgaux.org/archive/a7066/pdf.

The new 7066 form resolves several issues including the problem of unqualified ed examiners entering and getting credit for Uninspected Passenger Vessel, Uninspected Towing Vessel and Commercial Fishing Vessel Examinations making

the data we report to the various Coast Guard offices inaccurate.

Some of the changes made include:

- 1) Removal of the trainee option in Section I and II
- 2) Section II hours incurred and the number of examinations conducted on Commercial Fishing Vessels, Uninspected Passenger Vessels, and Uninspected Towing Vessels can only be listed by Auxiliarists holding a current/valid Letter of Designation as a 'AUX-CFVE' - Commercial Fishing Vessel Examiner, 'AUXUPV' Uninspected Vessel Examiner, 'AUX-UTV'-Passenger or Uninspected Towing Vessel Examiner from the Sector Commander/Captain of the Port/Officer in Charge of Marine Inspections under whom they work and from whom they have received orders to conduct such examinations.
- 3) In Section III Remarks, it is recommended that examiners indicate who issued their orders for doing the exams. It should be noted that ONLY Sector Coast Guard Uninspected Commercial Vessel Coordinators may issue orders for these types of examinations. Auxiliarists cannot provide Assignment to Duty for Uninspected Commercial Vessel exams.

In addition, there are instructions for logging travel and prep time associated with this activity on the ANSC-7029. For those members that are working on their AUX-CFVE, AUX-UPV or AUX-UTV qualification, their hours are reported on the ANSC 7030 form under either 80B Commercial Fishing Vessel Training & Qualifications, 80D – UPV Training & Qualifications 80F - UTV Training Qualifications. The examinations that members conduct during their training for those qualifications are entered on their PQS booklet so that they receive credit their required training examinations.
