AUX Assistance to CG Members during Lapse in Appropriations

As we work our way through the government shutdown, you may be wondering how you can assist our local Coast Guard units and personnel. An excellent way would be to donate to Coast Guard Mutual Assistance (CGMA). CGMA is "Coasties helping Coasties" and is similar to other organizations that help our sister services, such as the Navy-Marine Corps Relief Society, Army Emergency Relief, and the Air Force Aid Society.

Watch a short video that was produced in December that highlights CGMA and its support of Coasties during the shutdown. Then visit the CGMA website to learn more about the organization. One of the things you'll discover is that we, as active and participating members of our flotillas, are eligible for assistance from CGMA.

But, that's not why I'm writing this note. Today, CGMA is providing emergency assistance to Coasties until their paychecks are restored. ALCOAST 434/18 was released in December that describes the temporary policies and loans put in place to assist Team Coast Guard for the duration of the shutdown.

If you are considering any other form of donation please note the following guidance that has been sent to all Coast Guard members about general gift acceptance advice.

Gift cards are treated as gifts of cash and must be be for a commercial vendor, i.e. Walmart, Amazon, Starbucks. Gift cards that are pre-paid debit cards are not permissible. The value of the gift should not exceed \$20, as the \$20 per occurrence/\$50 per calendar year from any one donor rule still applies. Legal review of the offer is required. See the attached document for more information.

Instructor Development Course held

In the 4th Quarter of FY18, Division 23 hosted a division-wide Instructor Development Course (IDC) in Annapolis. Margaret Butler, Public Education Staff Officer says "the purpose and objective of the (16 hour) IDC training was to ready a new cohort of certified Auxiliary Instructor Trainees (IT) to assist division Flotillas to meet the vigorous demands for their Recreational Boating Safety (RBS) needs for 2019. In support of Commodore Thornton's FY19 Operational Plan for our 5th District Southern Region mission and vision to train our maritime volunteer staff to enable us to serve the public and build a safer boating community."

What's unique about this division-wide IDC Course is that it was a collaborative dual effort in partnership with the Maryland Department of Natural Resources (MDNR). The course readied candidates that successfully met all the qualifications as an Auxiliary certified Instructor Trainee to also receive certification as a MDNR State Instructor simultaneously. The MDNR certification permits Auxiliary Trainee Instructors to facilitate the DNR Maryland Safe Boating training courses in time for 2019 Spring boating session. The Division-wide IDC prepared 14 Instructor candidates to complete the training criteria fulfilment of their training thru Member Training as well as Auxiliary CORE Training delivered on GoToTraining platform.
