

Division 23 Member Training Opportunities

In-person & Revolving Boat Crew Program. As we focus on training in the fall months, the Division will be managing a rolling admission in our virtual boat crew program led by our newly appointed Staff Officer Operation, Jim Farrell. Sessions will commence at the Station Annapolis in January 2023, so please encourage your membership to be a part of our boat crew program. This is an expansion of the current virtual program being offered in the spring that will be offered yearround as opposed to only in the Spring months for both coxswain, boat crew as well recertifications. If you have a member in your flotilla that is interested in our boat crew training program, please contact Jim Farrell.

Department of Natural Resources (DNR) MD State Certification in Partnership with the Coast Guard Auxiliary.

On Tuesday, November 1, 2022, Division 23 held a virtual DNR On-boarding Orientation as well as refresher training on the zoom platform from 7:00pm to 8:30pm. There were about 41 members in attendance for the on-boarding event. As we continue to focus our attention on our recreational boating safety (RBS) and operational mission critical objectives we will be coordinating with DNR Police, Safety Education & Outreach unit to certify our current Auxiliary Instructors in preparation for the upcoming 2023 boating season next month. Seating will be limited, and we will be opening it to the Sector for participation so, notify us early. If you are interested in being Maryland State Certified or becoming a certified Auxiliary Instructor, please contact our Staff Officer Public Education Mark Bertacchi for more information. We plan on offering an Instructor Development Course (IDC) in the Spring of 2023.

Station Annapolis Open House

Division 23 partnered with Coast Guard Station Annapolis to host an "Open House" on Saturday, October 22, 2022, from 1:00am -5:00pm. Flotillas 23-01, 23-02, 23-03, 23-04, 23-06 and 23-07 supported the event. The purpose and goal of the

open house was to have informational booths and displays from several agencies, CG Small boats (TANB and RBS) trailered, a CG Helicopter and a Maryland State Police Helicopter. The open house was open to the general public of all ages and was a half day of Station Annapolis tours. The Sea Scouts actively participated and manned an informational recruiting booth. This jointly held outreach gave us an opportunity to engage with the general public and provide free safe boating literature as well as opportunities to inquire about our upcoming Maryland State Safe Boating courses. We had a steady flow of people in the community throughout the day to stop by and enjoy the festivities and pick up some free boating safety literature. Our Mascot Coastie joined us and was a big hit with the children.

Virtual Mini Boot Camp Training Summit

Looking ahead in FY23, the Division will focus on annual training as we did in fiscal year 2022. So, back by popular demand, Division 23 will host its annual virtual Mini Boot Camp Training Summit on 4-5 February 2023. We'll be facilitating this Training Summit using the Zoom and Breakout room functionality. We will have over 25 dynamic workshops for you to select from over the three-day weekend. We will have more than a dozen opportunities to complete the mandatory CORE/CT training (Privacy, Security Fundamentals, Civil Rights, Sexual Harassment, Workforce Resilience and Ethics). We will also have refresher workshops on "Conducting a Virtual MD Safe Boating Course", vessel examiner refresher and offering the annual mandatory Instructor Training and AUXDATA basics course. There will also be informative workshops on Watchstander protocols, diversity and leveraging social media to recruit and promote the USCGAUX.

Paul Feinberg, current Flotilla Commander wanted to introduce the best of Flotilla 23-04 by profiling and sponsoring stories of his members and their contributions to South River over the years. One member in particular hails from Buffalo NY, married for 49 years, retired, has a multitude of interest and hobbies with a zeal and thirst to serve and benefit his local community. Today's feature highlights a few accomplishments of Bruce Petro of South River Flotilla 23-04.

Petro has been in the Auxiliary since July 2008 and has donned many hats and provided his boat as a facility to the Auxiliary. As an operational coxswain and crew member he participated in various events in his Area of Responsibility (AOR) South River, from Shady Side, West River, Chesapeake Harbor Independence and Annapolis to Day patrols on the 4th of July including towing evolutions and SAR missions. He has visited other Auxiliary units in Florida's Clearwater, St Petersburg and Sand Key areas, corresponding with other members, comparing notes and narratives regarding meetings, recruitment, etc., building a bridge of friendships who share a common goal in another AOR.

He volunteered as both an Anne Arundel County (AA) police reserve officer and Maryland Department of Natural Resources Police (DNR) reservist; As an AA reserve police officer, he was highest ranking unit officer during his tenure, assisting with traffic violations, events, assisting motorist, etc. As a DNR officer he shared ride along responsibilities with regular unit officers tasked with holding customer boat during Vessel Examinations (VE) or game warden monitoring in season, size or quantity of fish or crab catches. Whether in forest responding to calls, poaching or on the water to support hazards to aids to navigation he has always shared a passion and devotion to duty unilaterally across each branch of service.

Bruce is an accomplished professional engineer who retired in 2005 and still belongs to the Engineering Society of his local area in Anne Arundel County (AA). He has been a judge for various science fairs both in AA and Fairfax County supporting projects to help mentor engineering students and has even donated books from his own library as a way to supporting their goals and ambitions to cultivate their interest and pass the national exam to enter into the profession. As an aviator, he's flown missions on the Chesapeake Bay for the Civil Air patrol Apollo squadron which at the time were single engine aircraft on routine SAR missions. This is where he and Michael Whitman former FC met and shared many activities in the Flotilla 23-04 and DNR. Bruce is not short on talent just time. He has many other hobbies including playing guitar, banjo and other instruments, wood carving, car restoration and shows and the list goes on. John Fewer awarded Auxiliary Commendation Medal



Roy Culley and I were invited to attend the Sector MNCR BBQ at Curtis Bay. During the BBQ, Sector Deputy Commander, CDR J. Bendle, presented me with Coast Guard Auxiliary Commendation Medal for my service as Sector

MNCR Auxiliary Sector Coordinator during the period January 2020 thru July 2022.

The citation read:

CITATION TO ACCOMPANY THE AWARD OF THE COAST GUARD AUXILIARY COMMENDATION MEDAL TO JOHN H. FEWER UNITED STATES COAST GUARD AUXILIARY

Auxiliarist FEWER is cited for outstanding achievement while serving as the Auxiliary Coordinator at Sector Maryland-National Capital Region, from January 2020 to July 2022. Demonstrating superb leadership and dedication, he provided an indispensable interface to the Command and fostered unparalleled Auxiliary coordination with Active Duty members, despite the challenges posed by the unprecedented COVID -19 pandemic. Employing a forward leaning posture, he quickly analyzed the multitude of ever evolving local, state, federal, and Coast Guard policies and provided sound recommendations with prudent risk mitigation measures to best utilize over 900 Auxiliarists serving across the Sector. Furthermore, when the Coast Guard initiated its new Auxiliary information technology solution, Auxiliarist FEWER quickly established himself as the regional subject matter expert. I-le assessed potential challenges that could negatively impact operational orders or subsequent financial reimbursement and provided vital training and system troubleshooting across both Active Duty and Auxiliary workforces. His actions ensured the continuity of Auxiliary operations to include over 550 patrols and nearly \$85,000 in reimbursements to our critical volunteers. Finally, he directly supported the response to the historic grounding the Motor Vessel EVER FORWARD, a 1,095-foot ship carrying 4,964 containers and laden with 700,000 gallons of fuel. Auxiliarist FEWER's dedication, judgment, and devotion to duty are most heartily commended and are in keeping with the highest traditions of the United States Coast Guard.

Kirby Garland Crosses the Bar

"Farewell, shipmate Farewell, Fair winds and following seas forever"

It is with great sadness I report that our beloved

Kirby Garland crossed the Bar on Friday, September 22, 2022 at 11:58 pm after a brief illness surrounded by family and his friends. Kirby Garland was an amazing husband, father, grandfather, and mentor to many and will be dearly missed. Kirby was committed to the U.S. Coast Guard Auxiliary to the very end of his life. Please keep his wife Violet and the Garland family in your thoughts and prayers This loss is felt throughout the Auxiliary at the National, District, Division, and D5SR beyond.

Kirby was a U.S. Navy Veteran. In December 1969 while serving in the Naval Reserves, Kirby was assigned to active duty in the Vietnam War. He served and piloted Naval gun boats and worked beside the Navy Seals while assigned at Dong Tam. He was a gunner and called in air strikes, and was later switched to serving as the U.S. Naval advisor on Vietnamese Navy boats. Kirby served his country valiantly and was discharged with honor.

Kirby was a very active member of Flotilla 23-03, West Annapolis and has received numerous recognitions and awards over the years after joining the Auxiliary nearly two decades ago on October 29, 2002. Kirby was fulfilling his second term as Vice Flotilla Commander (VFC) of 23-03 before he crossed the bar. In addition to his duties a VFC, Auxiliarist Garland was appointed as Division Vessel Examination Staff Officer (SO-VE) and as Flotilla Staff Officer Vessel Examiner (FSO-VE) where he performed such duties as overseeing division and flotilla special programs, coordinating and performing vessel examinations where he stressed the importance of following Maryland boating regulations and distributing boating information to the general public. He was a "Vessel Examiner Extraordinaire" always keeping

Commanders apprised of any situations that impacted the Auxiliary. Kirby was famous for leading, organizing and coordinating the Division 23 Annual Vessel Examiner Day at Sandy Point Park along with other VE Days across the Central Chesapeake Region at local marinas. Kirby exemplifies the core values of the Coast Guard Auxiliary on a large scale. He is the embodiment of honor, respect, and devotion to duty. He was a central and integral figure in his Flotilla and was an inspiration to all his shipmates, especially the younger members. He remained devoted to duty despite any obstacle thrown his way, whether it be the limitations that come with age or illness. He stayed the course serving the U.S. Coast Guard and U.S. Coast Guard Auxiliary with honor and distinction.

She was set to compete in the Pan-Am games in 1954 when she found out she was pregnant with her first son. So she made the trip as a spectator instead of a competitor. The birth of her second son prevented her from trying for the Melbourne Olympics. She was also active in Judo and traveled to different states to judge contests. Peggy won a gold medal in Judo in June 2003 at Fifth World's Master Judo Championship held in Tokyo, Japan. She attended survivor camp twice a year in the Pine Barrens in New Jersey. She loved to travel and just recently returned from a trip to Ireland and Scotland with her daughter-in-

During her more than 22 years of service to the Auxiliary, she received numerous recognitions such as the Department of Homeland Security Outstanding Unit Award, the Presidential Unit Citation, four CG Unit Commendations, a Special Operations Service Award, the Auxiliary Operations Service Award, and 15 Auxiliary service awards for VE/PV. Most notably he was the "Go to Expert" on operations while serving as District Staff Officer for Operations (OP), Assistant District Staff Officer-OP (ADSO-OP) Division Staff Officer-OP, Flotilla Staff Officer-OP, Auxiliary Qualification Examiner Coordinator (AQEC), and Qualification Examiner positions.

As said by his daughter, Donna, Phil was happiest when he was on the water. This fact can be attested to by all of us that had the privilege to crew for Phil on operational facility (OPFAC) 25852.



A special "good bye" to Phil was conducted on September 27th as he was "Buried at Sea " on the Memorial Stadium Reef off Tolchester, Maryland.

The "Burial" was attended by more

than 40 Auxiliary members on board seven OPFAC's. Phil's crew stood together to salute their Coxswain good bye aboard John Sill's OPFAC 32210. The ceremony started with Auxiliarist Jeff Foreman reading Lord Alfred Tennyson's "Crossing the Bar" over the radio after which Auxiliarist Paul Deafenbaugh sounded TAPS aboard OPFAC 32210 as Phil's ashes were lowered into the sea from Barry Cohan's OPFAC 46919. Phil's family laid roses onto the water to wish their father, grandfather and close friend to so many "fair winds and following seas" to conclude the ceremony. This was a truly remarkable event as we wished our shipmate farewell.

Posting Of Auxiliary National C-School Calendar

This message is to note that the Auxiliary National C-School calendar has been posted at http://wow.uscgaux.info/content.php?unit=aux00.

Members can now submit their Short-Term Training Request (STTR) via their Flotilla Commander (FC) and appropriate District Member Training Officer (DSO-MT) to their District Director of Auxiliary (DIRAUX).

Please note that funded training quotas are more limited than in previous years, so submitting a

STTR early will increase the members' chances of getting a funded seat. Any member that wants to attend on DIRAUX issued unfunded orders must check with the listed course Point of Contact (POC) to make sure there is space to accommodate such a request.

Update To Operational Auxiliarist (AUXOP) Program

- 1. This ALAUX promulgates an update to the Operational Auxiliarist (AUXOP) program.
- 2. In March 2022, the Chief Director of Auxiliary, in consultation with the National Executive Committee, chartered the Operational Auxiliarist Program Working Group (OAPWG). This working group was comprised of operationally-experienced Auxiliary and active duty leaders who were tasked with examining the program in its current form as a membership status. The working group met several times and after careful review and consideration recommended the following actions:
- a. AUXOP should remain a membership status.
- b. The designators in AUXDATA II which denote an Auxiliarist as having achieved AUXOP status (i.e., AX and AX2) should be merged into one designator: AX. This would be the only designator for AUXOP achievement. Use of AX2 would no longer be authorized regardless of how an

Auxiliarist achieves AUXOP. All Auxiliarists with the AX2 designator should have it changed to AX.

- c. A comprehensive data review should be conducted within AUXDATA II to ensure standardization of AUXOP entry into an Auxiliarist's record. Once an Auxiliarist achieves AUXOP, their status should be changed to AX and have the award "AUXOP-pin" added to their record. The AUXOP competency was inconsistently applied to the records of Auxiliarists who achieved AUXOP. It has proven unnecessary and should be removed from all records.
- 3. These recommendations are approved. Associated changes to current member records in AUXDATA II shall be made by the AUXDATA II Change Advisory Board by November 07, 2022.

Members of Flotilla 23-6 who desired to participate have been participating in a food drive to support the Chesapeake Cared Food Pantry since 2013. We once again members chose to support the food pantry with a Thanksgiving food drive to help those who are less fortunate than ourselves.

I texted with the Director of the pantry, Debbie Weber and asked her how many pounds of food they could purchase with the \$335. She texted me back saying "the \$335 will allow the pantry to obtain 1005 pounds of food. Each dollar donated now equals three pounds of food. Such a wonderful blessing to so many families".

I have been doing this since the beginning and it warms my heart to see how much good our Flotilla does for the community in which we live.

We are the United States Coast Guard




Patuxent Appreciation Days

Promulgation of the Emergency Management Specialist Performance Qualification Standard for the Auxiliary

- 1. This ALAUX establishes the implementation of the new USCG Emergency Management Specialist (EMS) Performance Qualification Standard for the Auxiliary.
- 2. Reference (A) announced the promulgation of the new Coast Guard Emergency Management (EMS) Performance Specialist Qualification Standard (PQS) (01 January 2022) and the cancellation of the Coast Guard Contingency Preparedness (CP) PQS as part of an ongoing initiative to align these standards more closely with the knowledge and skills required of Coast Guard Emergency Management Specialists. The current Auxiliary Contingency Planner (AUX-CP) PQS does not address all the knowledge and proficiency items in the prior CG-CP PQS. Likewise, there are significant differences between the AUX-CP PQS and the new EMS PQS.
- 3. Auxiliarists who currently hold the AUX-CP qualification will be allowed to keep this qualification. Auxiliarists who currently hold the AUX-CP qualification will be allowed to count this qualification toward competency requirements for the Auxiliary Marine Safety (Trident) Insignia.
- 4. Auxiliarists currently working toward the AUX-CP qualification will be required to complete the qualification prior to 30 June 2023.
- 5. The AUXDATA II records of Auxiliarists who currently hold the AUX-CP qualification and those that earn the qualification prior to 30 June 2023 will not be recoded to indicate that they have earned the EMS qualification. There should be no change to prerequisite qualification requirements for Auxiliarists to provide sector-level planning support. Neither the AUX-CP nor the EMS qualification should be added as a requirement for providing this type of support.
- 6. Starting 30 June 2023, the EMS PQS will become the standard for preparing Auxiliarists to

support Coast Guard emergency management planning and operations.

Chief Director's Final Action on National Board Recommendations

At the 2022 Auxiliary National Conference (NACON) in Orlando, FL last week, the following recommendations were placed before the National Board. They are summarized, with the Chief Director's final actions, below:

- 1. Recommendation: Modification to Requirements for Auxiliary Annual Operations Service Award (Originator: Director of Response Roy Savoca and District Commodore D9 Western Region Commodore Harvey Randall / Date: 04 April 2022).
- **a. Discussion**: The recommended change would allow Auxiliary participants in the air and surface operations programs to have credited toward this award all hours spent underway or airborne as well as up to 25 percent of associated training hours needed to prepare and remain current. Accordingly, the Auxiliary Manual (Commandant Instruction Manual 16790.1 (series)) section 11.A.11.f.(2) would be changed **from**:

"Displays the operational "O" device for underway (excluding underway for training), surface mission activity (60 or more hours), or for airborne aviation mission activity (excluding training) (30 or more hours). Support for on-thewater readiness exercises does qualify as operational service. No combination of surface and air operations is allowable for this award. Support activity includes those entered in AUXDATA with the activity code of U/W or ABN, excluding any with the submission code of TRN."

To:

"Displays the operational "O" device for underway, surface mission activity (60 or more

hours), or for airborne aviation mission activity (30 or more hours). Up to 15 training hours for on-the -water surface operations and up to 8 training hours of airborne aviation operations while assigned to duty, qualifies as operational service hours. Support for on-the-water readiness exercises does qualify as operational service. No combination of surface and air operations is allowable for this award. Support activity includes those entered in AUXDATA II with the activity codes of U/W, ABN, or TRN."

- b. National Board action: Approved.
- **c. Chief Director final action**: Approved. Appropriate changes to AUXDATA II will be made to place this change in effect for creditable activity beginning with CY 2022.
- 2. Recommendation: Amend the Standing Rules of the National Board Delete Rule 3.4 (Originator: Assistant National Commodore Chief Counsel Commodore Douglas Cream / Date: 10 June 2022).
- a. Discussion: Auxiliary Manual section 4.E.5.a.(1) -(7) defines the subject matter of proposals (recommendations) that may be brought before the National Board and considered for submission to the Commandant. That provision mandates proposals not consistent with (1)-(7) to be directed to the Chain of Leadership and Management (COLM) or to the "appropriate Auxiliary program committee..." The Standing Rules of the National Board of the Coast Guard Auxiliary (SR) 3.3 provides the procedure for the National Board's exercise of that responsibility.

SR 3.4 is superfluous and confusing. It has resulted in misunderstanding in its interpretation and application to SR 3.3 in the context of proposed policy recommendations.

Auxiliary Manual 4.e.5.a. provides that if the subjects of policy proposals consistent with subdivisions (1)-(6) come to NACO or DNACO in

accordance with Standing Rule (SR) 3.3(a) or (b), they must be presented to the National Board (the Board) for consideration following the described procedures in SR 3.3. recommendation does not fall within one of those six subjects, Auxiliary Manual 4.E.5.a.(7) provides that it may still be presented to the Board for consideration if NEXCOM approves and permits it to move forward. However, SR 3.4 could be mistakenly interpreted to provide that even if NEXCOM rejects the non-conforming recommendation under (7), any voting member of the Board may, by way of a motion made and seconded, still present the policy proposal to the Board for consideration. That interpretation would be erroneous.

SR 3.4 does not negate SR 3.3 because it requires that the subject motion is "in order;" a motion to adopt a recommendation whose subject matter is not consistent with Auxiliary Manual 4.E.5.a. is out of order because it is unauthorized. SR 3.3 requires that a recommendation submitted to the National Board for consideration must be "authorized by the Manual."

- **b.** National Board action: Approved.
- c. Chief Director final action: Approved.
