

Enhancing Boating Safety on Lake Norman Blythe Landing Radio Installed

After much planning and hard work, CG Auxiliary Blythe Landing Radio Station is finally a reality. On 24 August 2024, a USCG Auxiliary Fixed Land Marine Radio Station was installed at Blythe Landing on Lake Norman, North Carolina, a culmination of three-plus years of effort by members of Division 26 and numerous other entities. The purpose of the station is to enhance boating safety on Lake Norman by providing VHF marine radio coverage for CG Auxiliary patrols, and for communicating with local law enforcement marine units and the boating public.



It all started three years ago with an idea and initial discussions generated by James Barton of Flotilla 054-26-04 to place a USCG Auxiliary VHF Marine Radio Station on the south end of Lake Norman in order to fill gaps in coverage. After numerous discussions with multiple agencies, including Cornelius Police Department (CPD) and Mecklenburg County North

Carolina Parks and Recreation, a potential solution was floated to place a CG Auxiliary fixed land radio station in an unused former concession building at Blythe Landing Park, a busy boat ramp at the south end of Lake Norman on

Ramsey Creek. As discussions progressed, a decision was made to convert the building into a lake safety center not only housing the CG Auxiliary radio station, but also classroom space, conference room space, and facilities for members of law enforcement units to interact with the public. CPD and USCG Auxiliary Division 26 signed agreements in early-to-mid 2024 with Mecklenburg County Parks to provide services related to boater education, special events promoting safe boating, radio communications (specific to the sanctioned CG Auxiliary agreement), and a regular presence on-site. To date, several Boat America Boating Safety Classes and numerous Vessel Safety Check (VSC) events have been conducted. A children's Summer Camp sponsored by CPD has been held and many oneon-one boater discussions by members of the CPD, law enforcement agents, and Auxiliarists have occurred.

USCG Auxiliary Blythe Landing Radio

CG Auxiliary Blythe Landing Radio Station - so what is it and how did we build it?



The VHF fixed land radio station is located inside the building at what was formerly a concession service window, with views of the lake. The window can be opened to a vestibule that allows Auxiliarists on duty to speak directly to the boating public.

The installed equipment includes two ICOM M330 25-watt radios, power supplies, computers, and a planned power backup system. Two Shakespeare 4018-M 9db 19-foot-tall whip antennas with LM400 coax leading to the radios have been installed. The antennas are mounted at the top of a heavy-duty wood utility pole installed on

site, 61 feet above ground, with an aluminum mast and crossbar to hold the antennas bolted to the pole. Total estimated height above ground of antenna tips is 84 ft. with an estimated height above lake level at 92-94 ft. Operations tests reached another CG Auxiliary Fixed Land station 12.5 miles away in Sherrills Ford, North Carolina which is in direct line of sight. Transmissions from both stations were loud and clear with minor static from both stations, a better-than-expected result.

The utility pole was procured and installed by Lackey Enterprises Inc, owned by Darrel and Misty Lackey. Darrell assisted with assembling the mast, digging the hole for the pole with his equipment, lifting the pole into the hole with the help of CG Auxiliary crew, and setting the pole. Steve Riggan and Darrell Lackey then went 80 ft. in the air in Darrell's bucket truck to secure the coax and ground wire to the pole. Numerous CG Auxiliary members from Division 26 provided labor, assembly, and radio setup, and various "other duties as assigned," including photography. This was a true team effort!

What is next?

The CG Auxiliary Radio Facility Inspection approval is in process, and the station will officially go on the air as soon as approval is received. Members of Division 26 flotillas have committed to support activities at Blythe Landing, including operating the radio station for CG Auxiliary patrols and special events. The goal is to provide watch standing on weekends and holidays in order to monitor radio traffic from the public and to issue safety advisories.

A team made this possible.

The leaders of the project and members of Division 26 owe a huge debt of gratitude to everyone who worked over several years to bring USCG Auxiliary Blythe Landing Radio to reality. Organizations and individuals outside of the USCG Auxiliary also made this possible – without them the refurbished building and radio project would not have happened. These include but are not limited to: Greg Clemmer, Director of Operations for Mecklenburg County

<u>A Fond Farewell to our Shipmate</u> Hanna Nicole DeLuca

Members of Lake Wylie Flotilla were called to say farewell, fair winds and following seas on 6 August 2024 to dedicated member, Hanna DeLuca, who endured cystic fibrosis, succumbing after a bout of pneumonia and sepsis. Attending her funeral were Rick Croasdale and Beverly Butlin of the Flotilla. Hanna previously served in the Auxiliary in the Michigan City Flotilla in Indiana beginning in 2015. She was certified as an instructor and served as FSO-SR and FSO-MA. Hanna disenrolled before moving to North Carolina. On July 2, 2024, following a strenuous documentation process, she was able to join the Lake Wylie Flotilla.

On 4 May 2024, after dating for approximately two years, Hanna married another dedicated Auxiliary member, Adam DeLuca, also a member of Flotilla 26-02. Adam credits his relationship with Hanna as his reason for joining the Auxiliary. He stated, "The Coast Guard has interested me since I was young, but life took me on a different path. I first learned of the Auxiliary last year when Hanna told me she was a member back in Indiana. I was immediately interested and sent in an interest form right away. Hanna inspires me with her drive and desire to work and serve as much as she possibly can, even with all the difficulties she faces on a daily basis. Being a member of the Auxiliary allows me to see and learn how the USCG operates



while serving my community. I'm excited to learn even more as I continue to serve."

During and after the long application process, even when hospitalized, Hanna reached out. She kept in touch



while planning the classes she was going to work on and asked how she could still serve and help the Auxiliary, even after being admitted to hospice care. A truly dedicated member, Hanna was an inspiration for all of us and showed a great deal of devotion to duty. On 5 August, Mark Briggs, FC, presented a special Flotilla "Devotion to Duty" Award and Challenge Coin to Hanna, as she lay in hospice care. Adam accepted the award on her behalf. Also attending were her parents, her brother, and auxiliarists Ziad Nazif, Division 26 Commander, and Beverly Butlin, VFC, 26-02.

Hanna's husband, Adam, is also to be commended for his exemplary devotion to duty during this difficult time. Adam DeLuca earned the AUXOP member status in late May 2024. He also served at scheduled Vessel Safety Checks and performed Program Visitations, earning his PV certification. Hanna encouraged him, even as her health declined.

We will miss Hanna's dedication, resilience, perseverance, and her heart for service. May she be remembered by us all as an example of Honor, Respect, and most of all, Devotion to Duty.

Flotilla 26-04 Sponsors CPR Class

Following a Flotilla Meeting on 14 September, 2024, at the Fire Department on Highway 16 in Denver, North Carolina, Lincoln County Emergency Services provided a free Hands-only Cardio Pulmonary Resuscitation (CPR) class. The class was given by training coordinator Michelle Paget and offered to all members of Division 26.

The presentation was excellent and plenty of time was provided for practice. The Hands-only procedure is performed according to the following rubric.

- Check for a response and normal breathing
- Call 911 quickly and get an AED
- Compress in the center of the chest; push hard and fast
- Connect the AED and follow the voice prompts



Michelle described what to do if you determine someone is unresponsive. First call 911, and get the automatic external defibrillator (AED). Then, if the person has no pulse, start compressions. Do not stop compressions to check a pulse. If possible, switch out with another person every two minutes. When the AED is turned on, it

gives instructions. It is good to store scissors, a razor, shaving supplies, towels and gloves with the AED because the pads need to go on bare skin. Sometimes a shave is necessary. If the person does not respond to the AED, continue CPR while waiting the two minutes it takes for the AED to recycle and allow you to use it again.



If reading all this makes you nervous, take a CPR course. It is not difficult and mouth-to-mouth resuscitation is not required. Compressions are the most beneficial means of CPR. You could save the life of someone you love.

The members of Division 26 who attended are Jim Loftin and Dan O'Brien, 26-01; Betty Laimak 26-03; James Barton, John Dibbins, Gary Eifried, Sharon Eifried, Tony Marciano, and Sydney Newcombe, 26-04.

Michelle pointed out that it is essential to always know the address where you are needing help. The response to a 911 call in Lincoln County takes approximately 2 to 3 minutes for the police, 4 to 5 minutes for the fire department, and 7 to 8 minutes for the emergency response system (EMS) to arrive. Be assured that the first responders on a fire truck are CPR certified, and will start to care for the victim while awaiting EMS. Michele also demonstrated the ways EMS helps victims with compromised airways, possibly from a drug overdose.
