We met in a local condo association clubhouse but there was no storage. Then we found ourselves meeting by Zoom. Patrols were suspended, vessel exams stopped. We were becalmed.

Again camaraderie to the rescue! Our local American Legion Post 76, nicknamed "The Ghost Post," was also in the process of rebuilding and acquired the use of a former gym. United in service, we were allowed to share their quarters for our meetings after in-person meetings were allowed.

A sense of purpose was starting to return. Patrols became active and Tom Maloof ran one surface training patrol in January, with two more in February. Gary Davis was back on the water again as crew. Tom, a professional pilot, few one AUXAIR patrol in January. He is working with the active duty Coast Guard to plan a pollution response drill on the Anclote River.
