October Division Meeting Notes

Meeting started at 0900 with the Pledge of Allegiance and a moment of silence in remembrance of those members of the service who gave their lives for their country and for those who still serve.

Paul Pelletier, Division Commander (DCDR), thanked flotilla commanders for a great job in 2014. He announced that Rear Admiral John Korn, USCG, would be at Station Yankeetown from 1300-1500 on 22 October for an all-hands meeting. Members of the Auxiliary were invited to attend. The DCDR announced that the division Change of Watch would be held on 15 November at the Plantation Inn located in Crystal River. The cost is \$20.00 per person, and checks should be sent to Don Jones, SO-FN.

Diane Berman, Division Vice Commander (VCDR), gave a short report on both NACON and D-Train. She said it is her belief that Admiral Paul Zukunft, USCG, the new Commandant of the Coast Guard, will be a staunch advocate for the Auxiliary. She also said that the new DIRAUX, Commander William Seward, USCG, will be a big plus for the Auxiliary as well. Diane mentioned that the new VE manual will be available soon and thanked Andy Render, DVC of the V branch, for his fine work on the manual. Ms. Berman reported that AUXLMS courses can now be taught as member training at flotilla meetings in order to have all members current on this required training. She reported the results of the District 7 election at D-Train. Robert Weskerna, presently District Chief of Staff, was elected District Commodore, and Judith Hudson, former D-CAPT (E), was elected District Chief of Staff. Paulette Parent, affectionatelv known as the founder of AUXFS (Semper Gumby), and former Division Commander of Division 8, was elected D-CAPT (W). Gary Barth, presently D-CAPT (E), was reelected to a second term, and Carl Motes, IPDCDR of Division 17, was elected as D-CAPT (N). All assume their new offices on 1 January 2015

Craig Elliot, IPDCDR, reiterated the consensus that the new District Commodore-elect Bob Weskerna will be a real asset to the District. Craig reported that there is a proposal being considered that inflatable life jackets will no longer be permitted but it is just being looked at for now.

BMC Paul Chandler, USCG, Office in Charge of Station Yankeetown, thanked Chuck and Kitty Dolan for their AUXFS help at the Coast Guard Day celebration at the Station, and he thanked Andy Render, SO-OP, for his work on developing a facilities manual, including photos and pertinent information such as size and draught of each of the Auxiliary facilities in the Station's AOR. The manual helps Station know which facilities would be useful in certain types of call-outs.

Linda Jones, the Division Fellowship Coordinator, reported that there are 36 members signed up for the Change of Watch on November 15 and urged members to send their check for \$20/per person by 31 October.

Paul Pelletier, DCDR, announced that the division now has its own Challenge Coin, which he passed around for everyone to see. He said it will be given to outgoing FCs and SOs for their service to the division. Diane Berman, VCDR, described a table at D-Train offering literature on the Mutual Assistance program, a service to the USCG and also Auxiliarists, which gives loans and grants to members needing financial assistance or who wish to pursue a college degree. She distrib-

uted literature and asked Auxiliarists to help support the Mutual Assistance program by sending a donation. Larry Berman, FC, 15-5, and who facilitates the 4-hour TCT, suggested having only two TCT classes for 2015, due to a decrease in those needing the training. The bridge agreed.

Lastly, division elections were held. Diane Berman was elected Division Commander and Andy Render was elected Division Vice Commander. They were the only candidates-there were no nominations from the floor. The meeting ended at 1030 hours.

SAR Mission off the Coast of the Suwanee River by Jim Simon, FC, 15-1

On the morning of August 28, Flotilla 15-1, Crystal River, was called out by Sector St. Petersburg to assist in a Search and Rescue mission off the coast of the Suwannee River. Two men (71 & 45 years of age) left the Suwannee Marina the previous morning in a 16' center console boat. When they did not return that evening, the U.S. Coast Guard was notified and a search began around 3:00 in the morning. Don Jones, Jodi Simon, and I with the *Salt Shaker* headed to Suwannee around 10:00 am. There, we met up with Don Sorli from Flotilla 15-7, in whose AOR the Suwannee River resides. We had orders to search just off shore and to the north from the Suwannee channel. Water just off-shore is very shallow which made it difficult to search close in. After being on the water for about 30 minutes, we received orders from Sector to conduct a "Tract Line Search" pattern. Coordinates were received, entered into the GPS, and we headed to our CSP (commence search pattern) starting point. We had just notified Sector that we were beginning our search when a Fish and Wildlife Commission (FWC) vessel located the missing boat with both occupants 16 miles west of Suwannee marker #1. The boat had capsized with only about 3' of the vessel out of the water and with both occupants still with the boat. They had been out there for about 28 hours. Info was not available as to the time the boat capsized or the reason, but both men were in need of medical attention when they arrived back at the boat ramp.

This was a great opportunity for Flotilla 15-1's operations program. It shows that we have the personnel and facilities to assist the Coast Guard in SAR operations outside our AOR. The fact is that on this day's SAR, we spent most of our time traveling, and the outcome of this SAR was positive with the safe rescue of the two boaters. Our crew was prepared for a long afternoon on the water, especially in an area with which we were unfamiliar. Having Don Sorli on board was a great asset

DIRECT SUPPORT TO USCG

MEMBER TRAINING

Our PE classes are temporarily on hold due to the sudden illness of our FSO-PE. However, we anticipate scheduling classes again when conditions permit.

CHALLENGES

During 2014, our flotilla has so far endured the loss of two members who crossed the bar, one new and one nonactive member disenrolling from the Auxiliary, and one member transferring to another flotilla. Additionally, some other members are contending with health issues, either acute or chronic. Clearly we need to recruit more active and younger members, who can be socialized into the Auxiliary and who will be willing to step up to hold both elected and appointed officer positions.

I, as well as several of our key members, continue to believe that one important operational capability for an inland flotilla such as ours lies in the radio communications area. We intend to continue to encourage members to become licensed Amateur Radio operators as well as Auxiliary Telecommunications Operators. Ultimately we seek to establish a complete Auxiliary radio station facility, which would include HF SSB, VHF, and UHF capabilities.

SO-OP, Andy Render—Operations



During the District 7 Training Conference (D-TRAIN) in Orlando this past September, I attended a workshop on Operational Facilities. Much of the information covered was routine and served as a refresher. There were, however, several items that, while not new, were good reminders for all of us.

First, it was strongly stressed that the Offer-for-Use form (ANSC 7003) is considered a <u>legal docu-</u> <u>ment</u> and cannot be updated or modified by <u>anyone except</u> the originator of the document. Therefore, please pay particular attention when completing the form so it does not need to be returned to small and seemingly trivial corrections.

the boat owner for small, and seemingly trivial, corrections.

Also, use both feet and inches when describing the length and width of the vessel. As a reminder, when designating your facility number, the first two numbers which designate the length of the vessel should always round <u>down</u> to the lesser length. For example, if your vessel is 23' 9", the prefix for your OPFAC number would be "23". For flotilla-owned facilities, you should use the manufacturer's advertised length.

Another important item is that the crew and coxswain serving on any vessel that can reach a speed of 35 MPH (30 knots) must wear an orange or yellow PFD rated for speeds of 50 MPH or greater. The vessel's maximum speed rating cannot be lowered when renewing the Offer-For-Use form, unless there is documentation explaining the reason for the change in speed capability.

Once your vessel has been accepted for use by the DIRAUX Office, you will receive a letter of acceptance. This document must be carried aboard at all times.

Don't be surprised if when a QE is aboard your vessel, they conduct an inventory of the safety equipment carried aboard. That is a part of their QE mission.

Overall, the workshop was very informative and contained a lot of good information. If you have any questions about the above items, please let me know.


