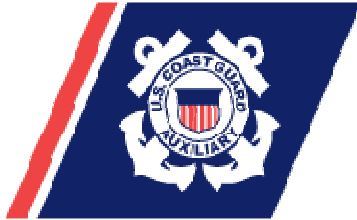

completed all elections at this time. The request
for gate security support at Station Canaveral
resulted in 46 hours of Auxiliary support
provided for this mission.**

S.O. REPORTS

**SO-CM Pete Anderson: 72 hours of watch
standing at Station Canaveral this month and 5
D7 HF nets with 57 stations participating.**

SO-CS Donna Miller: Our Division web site is current and all reports posted and current.

SO-FN Donna Miller: Division Financials current and yearend audit notices sent out to Division Flotillas.

SO-HR Sharon Breece: Multiple applicants continue from our E –responder program. Flotillas reminded to focus on disenrollment procedure in a timely manner. Reports from all Flotillas this month indicating positive growth that should result in an overall increase in membership as we start the New Year.

SO-IS Barbara Carolus: assisted with providing passwords to AUXDATA to new FC in 17-11. Flotilla 17-10 FSO-IS input all entries related to Mission activity for this Flotilla bringing input current. Excellent work getting current.

SO-MA Richard Barada: Obtained multiple items for various Flotillas and distributed them to 17-06 and 17-11. Personally participated in two

events this month as part of the Honor Guard team.
