This Incident Command System training is designed to help emergency responders & others understand command & coordination responsibilities during emergencies & disasters.

### Objectives:

- **ICS 300 Intermediate ICS for Expanding Incidents:** Provides training & resources for personnel who require advanced knowledge & application of ICS. Course expands upon information covered in the ICS 100 & ICS 200 courses.
- **ICS 400 Advanced ICS:** Provides training & resources for personnel who require advanced application of ICS. Course expands upon information covered in ICS 100 through ICS 300.

### Prerequisites:

- **ICS 300:** ICS 100, ICS 200, IS 700 & IS 800
- **ICS 400:** ICS 100, ICS 200, ICS 300, IS 700 & IS 800

### Audience:

- **ICS 300:** Intended for individuals who may assume a supervisory role in expanding incidents or Type 3 incidents.
- **ICS 400:** Intended for senior personnel who are expected to perform in a management capacity in an area command or multiagency coordination entity.

### Registration:

Please follow the steps below to register for these ICS courses:

1. You must register for ICS 300 & 400 courses on the HSEM Training and Registration Tracking System (TRT). If you do not have an account, please go to HSEM's website, click on the Training Tab and go to the Training and Registration Tracking (TRT) link to register for an account at: <https://dps.mn.gov/divisions/hsem/training/Pages/default.aspx>. Approval typically takes 1-3 business days. You will receive an email with your User Name and Password. **Note:** If you do not provide your agency and role and only give a non-descript email account (Gmail, Hotmail, etc.), it is unlikely your account will be approved without a request to supply further information.
2. **Important:** Students should scan and send their prerequisite completion certificates (IS 100, 200, 700 and 800) prior to the course to [HSEM.Training@state.mn.us](mailto:HSEM.Training@state.mn.us).
3. **Note:** If a student is not in the HSEM Training and Registration Tracking system, they cannot receive a certificate. If a student has not turned in their prerequisite completion certificates to [HSEM.Training@state.mn.us](mailto:HSEM.Training@state.mn.us), they will be marked as incomplete.
