At the July meeting the flotilla showed off its newest asset the Kaylee-Annie. Our new facility, a 22 foot Misty Harbor pontoon boat, is owned by Flotilla Commander Steve Gress. The vessel has been accepted as a Coast Guard Auxiliary Facility and was officially placed into service on Saturday. She is ready to receive orders and begin operations.

Members are encouraged to get involved in the boat crew program. Currently we only have one coxswain, Steve, and two crewmembers, Dan and Joanie. That puts a big limitation on availability and what we can accomplish. We currently have two more members working on their boats to get them accepted as facilities but with only one crew we can still only send out one boat.

#### **Public Affairs**

What is "Public Affairs and who's responsibility is it? The Coast Guard Auxiliary is a public service organization and as such our customers and our supporters are one – the boating public. We need their support and co-operation in order to accomplish our mission. To that end we need to earn the respect and trust of the public. That is where public affairs comes in. I have been listening to various complaints, both mine and of others, about the changes we keep seeing in the Auxiliary. Changes can be good, if it betters the operation, or bad, if it makes matters worse. And either way change is stressful. However before one decides good or bad one must first decide if "change" is really taking place.

In any organization each "generation" teaches the new generation how to conduct business. The problem is the routine tasks tend to erode over time and become more of what we think it should be instead of what the policy really is. As time goes on this erroneous policy or procedure slowly becomes the standard which is what is passed on to the upcoming generation further establishing it in the organization as correct policy. The rub comes when someone actually reads the manual and realizes what we have been doing is incorrect, and probably has been so for years, and brings that to everyone's attention. Now we make the necessary "correction" which comes rather suddenly, compared to how we got there to begin with, and we are faced with that dreaded "change in policy" which in the end it is not. Having been there before in other organizations I have a tendency to read the manual which has caused interesting conversations with those senior members who hadn't read the manual at least in a long time or are simply doing business as they were taught. Some gracefully read the manual and agreed with me or were able to point out where my interpretation was in error. Some on the other hand had no sense of humor at all. I could read their mind, "who is this new guy think he is telling me I'm not doing things right?" Or "read the manual? Heck I wrote the manual!"

Change is inevitable as we learn new, safer and more efficient ways of doing business. No one is particularly fond of change, including me, but before you get your dander up make sure 1) It really is change and 2) It is purposeful and positive change.

On another note: This weekend I came to a realization. At times my enthusiasm has waned over all the time spent training, learning, and meeting more requirements. It does get old. Our flotilla has been at this for5+ years now. Then while on a routine patrol in LaCrosse, the fun part of crew training, we received a radio call from a river barge. The captain reported some kayakers playing around dangerously close to the moving barge. We went to check it out expecting to find some kids horsing around unknowingly flirting with death. What we found were three adult women in two kayaks who were caught up in the current and wind and being swept downstream trapped in the main channel. The only one wearing a PFD, though not fastened, was 4-5 months pregnant, unable to swim alone and quite scared. The other two were in a two seater and sitting on their PFDs! They were already a mile and a half down from where they were supposed to be with no hope of ever getting back and darkness was only an hour or so away. Their fate was pretty grim. Their choices were A) get run over by the next barge, B) get swamped by a passing speed boat or C) go over the next dam. D) a night in the woods as mosquito dinner was probably their most favored outcome. We were able to recue these ladies and return them to their families.
