Food was provided by the Park, and prepared by Tony Scaglione, and again helped to provide a platform for engagement. New this year, Tom Every, Kim Walsh and Sea Scout Ethan Laverack, set up a table at the 8 bay launch ramp so Tom & Kim could do VSCs on that side of the Park. They found many launch ramp users were not nearly as well prepared for boating as Marina residents. However, these visitors were at least open to a discussion regarding requirements and accepted literature, paddle craft stickers, etc.

Diana Robinson and Dale Campbell set up at the original display area by the marina basin to attend to slip holders and transient boaters as before. Reporting Your Hours

01D MISSION CODE

The 2018 boating season seems so long ago. Let's go over how patrol hours are reported. Coxswains report your underway time AND what's known as "standby time" at dockside. The current policy was instituted to better guard against crew fatigue. Crew members should take care not put any time on a 7029 which may already have been credited by the coxswain.

01D is the designation for "dockside" time spent doing equipment checks, boat prep, GAR plus "standby" time when you break for lunch or take on fuel. After you end the mission by calling Oswego, it will account for the time spent putting the boat back in order.

Whoever is keeping the patrol log should begin with time you started prepping for the mission. Then note when you called the patrol into Oswego and subsequent communications, any changes in patrol status, when you ended the patrol at dock, and when the post-operations activities concluded.

- If you are a coxswain, kindly give your crew a rough idea of how much actual patrol time they earned for the mission. We all like to know when we hit the magic 12 hours!
- If you are crew, feel free to ask your coxswain or me if unsure about your time on a specific patrol.
- For all, be aware that "standby" affects underway time. Coxswains are being told to report <u>dockside</u> breaks for rest room use, meals, fuel etc. That time will NOT count as underway time.

Orientation Patrol

25 June 2019 - Following up on a request made by BM1 Miron, Kim and Kevin Walsh made their facility, "Summer Place" available for an orientation patrol. The idea is for gold team from Oswego to come aboard and see the actual areas that our flotilla regularly patrol, thus increasing their situational awareness of our area.

On a rare sunny, summer day we received Hunter Liming and John Buttgen, from Station Oswego, as our guests on board, went through orientation, GAR and plans for the patrol. With Kevin Walsh at the helm we headed for the flotilla base building on the inlet in Ithaca. All during our travels, Kim used a chart of Cayuga Lake to point out landmarks, various ATONS and talked about the wide range of depths to be encountered. At the inlet, debris from recent heavy rains cause us to cancel that part of our plans. We turned north past Crowbar Point and Taughannock Park, then eastward toward Milliken Station before heading south and back to Myers Point again, covering roughly 20 miles overall.

Both guests remarked that it was VERY educational for them and observed that lake patrols on Cayuga are quite different from what they are used to. Communications Patrol

Subject: Non-Federal VHF National Interoperability Channel Testing Results

Thank you once again to Brian and Jack (Tompkins County Emergency Services) for the cooperation and support you provided in allowing Coast Guard Auxiliary Flotilla 22 to do VHF Interoperability Channel testing with the Tompkins County Department of Emergency Response. It was a beautiful day on the lake on Monday and testing went as planned. Additional explanation of the testing results is provided below.

We used three different radios during the testing as follows:


- Kenwood TK-2160 land mobile radio We had two identical units. These were old hand me down portable units that put out 5 watts. After testing at five locations it seemed to us that the #2 unit was performing better than the #1 unit and we just tested with the #2 unit at the rest of the locations.
- ICOM mobile radio with good external antenna - This radio put out 10 watts but it could not be programmed in 2.5 khz. increments so we could not set it up to the exact VCALL frequency. The closest we could come was 2.5 khz. off center which resulted in less than optimal

performance. We stopped testing with it after test Location 5.

We were able to establish contact at every location but results varied significantly. To keep things simple in the results log we assigned communications quality on a 1 - 5 scale with 1 being poor and barely understood. The first results column indicated what Tompkins dispatch told us they were hearing. The second column indicates what we were hearing from Tompkins.

I was a bit surprised by which locations did best and worst. A simple summary of that is:

- Poor locations Locations 1, 2, 3, and 9. These were at our base in the Inlet, the South end of the lake, and the West side of the lake near Crowbar Pt./Girl Scout Camp. I was hoping we could hit the Danby tower from there well but apparently that did not happen.
 - Acceptable locations Locations 4, 5, and 8. Those were further up the lake on the West side and on the East side at Myers Point. We were told by Dispatch that Location 5 was going through the Enfield tower. We could at least understand each other.
- Best locations Locations 6 and 7. This was surprising to me because they were further up the lake on the East side. Dispatch told us we were being heard through the Enfield tower. Apparently being on the East side of



the lake away from the West hills provided a more direct path to the Enfield tower.

• We did one extra test at the end of the tour just to repeat testing at our base location in the Inlet. Same poor results.

Below are some basic observations, suggestions, and recommendations on how we might improve Interop communications going forward:

 Better radios - Coast Guard Auxiliary District 1 has an extensive network of communication systems and support personnel. They operate on the Interop channels with New York City and surrounding counties. They have tested and recommend ICOM F1000S Portable and ICOM F5021 Mobile radios for CG Aux. operation on Interop channels. That might improve our communications capability and we would consider purchasing portable units if Tompkins is moving forward with Interop support.

- Even with better radios, due to the challenge of engine and other noise, Interop communications will not be as good as direct P25 radio communications. District 1 reports that the conventional analog radios cannot hear the trunking system's tones (don't pass through). We will have no tone verification that we are actually transmitting into the trunking system.
- Enabling Interop comms on a tower in Lansing, such as Brown Road, should provide pretty good lake coverage into the current weak areas.

Hope this helps you folks out. We look forward to enhancing comms with you using the Interop channels.

Boating at night

Taking our boat out at night is not my favorite thing. I have found in the past when acting as crew on other facilities that I have difficulty keeping an accurate picture of where I am in relation to the shore. The evening we went out for the Taughannock Park fireworks was no different.

There are several experienced boaters near our slip at the Marina and I had had a discussion about going out at night with them. The two that I talked to were as reluctant to venture out past the marina entrance as I was.....that was re-assuring in some ways (that my instincts were correct) and disconcerting in other ways (because I WAS going out).

We left our slip that evening with a very experienced crew (but my first night patrol at the helm), but we DID have a navigation plan which actually helped greatly as the night progressed. We departed Finger Lakes at about 2000 and headed north and west up to Taughannock Park. The fireworks had been postponed from Saturday night, so the boating crowd was fairly small. The Tompkins County Sheriff's boats were out and stayed in closer to shore, we stayed out to the east. There were very few violations or problems that evening, and we got to watch a very nice fireworks show. The biggest problem during the actual operation was that we had not thought to review the steps on how to dim the darn GPS before we started!! We hadn't been out at night before and keeping our night vision was almost impossible if we used the GPS. The show ended and we began to make our way back south towards Finger Lakes after the vast majority of the boats (to include the Sheriff) had already departed.

It was quite dark, and we kept to the west side of the lake, our plan was to continue south until we got abreast of the salt mine (which is VERY well lit at night) and then take a 90 degree East turn. The plan was a good one, EXCEPT I was looking right at the salt mine but not realizing I was looking right at the salt mine. Kim said "We are right across from the salt mine" but it looked different at night all lit up. She was right, it was the salt mine. But it took me a minute to get my senses and my eyesight and my brain all on the same frequency. Once I recognized (WITH THE ABLE DIRECTION OF THE COXSWAIN) where I was, we turned East and started looking for the flashing light of the Yacht Club buoy which is south of Finger Lakes Marina. Our plan was to turn East after coming abreast of the salt mine and then look for the buoy (it has a REALLY GREAT Light on top of it). Once we got to the buoy, I knew that if we headed 360, we were heading directly into the entrance to Finger Lakes. The Finger Lakes entrance is marked with a green light on the East entrance shore and a red light on the West entrance shore.

We found the buoy (with that GREAT LIGHT) and turned to 360 as we went by. Being able to follow our navigation plan gave me a little more confidence than I probably would have had if we hadn't discussed it beforehand. Trouble is even after we turned toward the Marina entrance it was very difficult to pick out the red and green lights marking the entrance. Finger Lakes has also put up two bright white lights on each side which was also a help. We slowed down even more than we had been and attempted to pick out the red and green lights. It wasn't easy, but I did get a visual sight WITH THE HELP OF THE CREW. We were inching along and trying to make sure we were square with the entrance, but the tail lights of cars made picking out the red and green lights we NEEDED very difficult. Again, with the help of the coxswain and crew and going very slow I was able to pick out the entrance and get into the Marina. There was virtually no wind which was very helpful. We are docked next to an extremely large and expensive boat, just getting safely moored

without touching it is always a stressor, but at night...... WITH THE HELP OF THE CREW we were able to very slowly make our way into the slip without contact with our neighbor (another HUGE reason for this was the lack of any wind)!! So, what did I learn from that experience???

- 1. Have a sound navigation plan which you put together in daylight and have gone over several times in your mind.
- 2. KNOW HOW TO DIM ALL DASHBOARD equipment. GPS, radio, engine meters, etc.
- 3. Go out with experienced crew for a night familiarization ride at the beginning of each season, before you plan a more complicated patrol or get called out on a SAR mission. Get a feel for what specific landmarks look like at night and have a standard way of lining up your boat for the entrance to where you want to go (and, of course, a backup plan).
- 4. Have a small flashlight handy (Tom Every's is perfect), in order to provide just the right amount of light in just the right place.
- 5. USE YOUR CREW. We had an excellent crew who were invaluable helping to get our situational awareness where it needed to be.
- 6. You cannot go too slow at night. By going slow, you give yourself the opportunity to get situational awareness and not overtake something when you are trying to get situational awareness.



Each yellow dot on the map represents a HAB reported in the past two weeks. Click on a dot for more information, including the date it was reported, the waterbody name, and pictures. Click on the arrow at the bottom of the screen to view a list of reported HABs.



Know it. Avoid it. Report it.

If you see a HAB, please use the new <u>reporting form</u> to submit a report to NYHABS. Because waterbodies may have HABs that have not been reported to DEC, we recommend <u>avoiding contact</u> with floating mats, scums and discolored water.

If you, your family, or pet have been in contact with a HAB, please rinse with clean water and report any symptoms to your local health department.
