

Finger Lakes Boat Show

The First Annual Finger Lakes Boat Show finally took place on 3/31-4/3 and 4/7 - 4/10. The show's organizer, Explore Ithaca, set us up with a good display area and Ben did a nice job making the posters. Although attendance was light, I believe participating in it was a big success for us because of the interaction we had with various organizations and individuals in the boating community and the safety information they learned from us.

There was a nice combination of paddlecraft, power boats, PWCs, small sailboats, and other equipment on display. Marinas and boat dealers from the Finger Lakes area were represented. Some of the folks that we had good conversations with, developed relationships, and are having follow up interaction with are:

- The Ithaca Yacht Club is talking with us about doing do a boater safety course or some other specialized safety/navigation training at their place
- Chris Allinger from the Cayuga Radio Group will be putting PSAs on all ten of their stations publicizing our boating classes
- Lansing Harbor Marine will be renting out five new Veranda pontoon boats this year. John Frieman is talking with them about doing VEs on them.
- We chatted with the M/V Teal folks about their tours. We also talked with a woman who does sailboat tours.
- Explore Ithaca /Waterworks will be doing tours of the lake with their new Duffy 18' and 25' electric boats. They will be operating with a six-pack license.
- I chatted with the Executive Director of the Cayuga Lake Scenic Byway about their promotion of tourism and the Blueway Trail

We fielded questions and educated people on many subjects including: Aux volunteer missions, Inlet dredging, ABS class schedule and replacement of lost ABS certificates, Brianna's law, radios vs. phones for emergencies, fire extinguishers and cut-off switches, vessel inspections, who has law enforcement authority on Cayuga, and navigation rules (right of way between vessels).

The show organizer said it will take place in future years at different locations in the Finger Lakes including possibly at Lansing Harbor Marine. **Thanks to all our volunteers who helped setup and support it. Great job and I think the show benefitted from and greatly appreciated our participation.**

Member Training Minute – Vessel Safety Checks

This month article focuses on how to become a Vessel Examiner and importance of Vessel Safety Checks (VSCs) in executing our Recreational Boating Safety mission. VSCs are one of the best ways to get direct interaction with boaters and provide information specific to their type of boat and where they most often use it.

The initial certification requirements are quite simple and can be completed rather quickly:

- Complete the open book test (no proctor required) with a score of 90% or greater
- Participate in 5 VSCs with a certified Vessel Examiner.

The Vessel Examiner test is pretty straight forward. However, the variety of watercraft and nuances of federal and state requirements means you'll want to have references available and might want to seek out additional opportunities to work with an experienced Examiner when first inspecting a paddlecraft, PWC, sailboat, etc.

You'll encounter an immense range of boaters when visiting marinas and launch ramps, such as:

- Boaters who know the requirements and seek a VSC every year.
 - o If they have discrepancies, they are usually simple ones, such as their flares have expired
 - The best topics of conversation are new requirements, such as the phase in of Brianna's Law and the change to fire extinguisher regulations
- First time VSCs new vessel owners have a huge range of boating knowledge and compliance with regulations
 - May have bought the boat used with safety equipment included...but is it in date and do they know how to use it?
 - o What is their boating knowledge and experience?
- Paddlecraft and small sailboat owners
 - Paddlecraft VSCs are quite simple from the equipment point of view and focus on the opportunity to educate the boater, if needed
 - They aren't required to complete a Boating Safety course and may have a skewed view of "Rules of the Road" -- believing they have absolute "right of way" and not understanding about requirements not to block channels and to maintain their course and speed to allow motorboats to safely give way
 - o You should carry whistles (if available), "If Found" decals and Paddle craft safety literature

Vessel Examiner is an extremely rewarding certification for extroverts! It's a little more challenging for introverts, but definitely worthwhile. Please contact Kim or one of our current Vessel Examiners to learn more. It's one of the easiest qualifications to earn, but you'll continue to learn while performing VSCs, due to the many questions you'll be asked. VSCs are a critical component of our Recreational Boating Safety mission and can be extremely rewarding. They're also a great opportunity to promote Boating Safety classes and recruit new members.

PPE Now in AuxData

Imagine if you will a corporation with over 26,000 workers in locations in each of the United States. Many of those workers have been issued equipment, but the company doesn't know exactly who had been given what. They don't know what hardware is still in good repair, its value, or how to project replacement costs.

That's similar to the situation the CG Auxiliary has been in. The new system improves both financial accountability and safety. Before, there was no centralized inventory or inspection management system. Now, DIRAUX and your own coxswain can tell whether you have gear required for a patrol – and there will be a green box if its inspection status is good. A flotilla's Rescue and Survival Systems

officers can plan ahead to make sure no one's PPE is out of inspection, and AuxData will send members automatic email reminders when their gear is due for inspection.

The new PPE module in AuxData really only affects crew, equipment managers, and flotilla staff officers. All major wearable gear items (except PLBs) are already in the system.

Once PLBs are in...

- ➤ Boat crew & trainees who already comfortable with AuxData will only need a brief intro to the PPE module.
- If you are a crew/crew trainee member who doesn't/won't/can't use AuxData, please contact me to schedule individual training by phone to get you up to speed.
- Anyone issued a PLB should be able to record their own PLB monthly tests. There is work underway for monthly AuxData-generated email reminders which would automatically update PLB inspection status if the member replies that it passed, but that's still in the planning stages. Until then, it will mean opening your AuxData account monthly, going to the PPE tab, clicking a box and maybe entering a date. That's it!

One of the required fields in the PPE module is an initial, one-time "Acceptance" by the member to verify they've received the described item. The system tracks 7 possible items, so for each crew member that means up to 7 records which need to have the acceptance box checked. Although I can check off acceptance on behalf of a member I'd like you to at least know how to look at the records and which discrepancies to ignore.

Let's say you open your AD-II record now. One of the tabs is PPE. If you were issued gear it should all show up there. If you want you can "Accept" my entries now by clicking on the box for that. Keep in mind:

- PLBs are not in yet, probably coming in the next few weeks.
- They are not tracking minor items such as mirrors or whistles. They are only tracking:
 - Anti-exposure coveralls
 - Type III PFDs
 - Boat crew survival vests
 - o PLBs
 - Rain gear
 - Gear bags (empty)
 - Float coats
- We've been told to input a uniform issue date of 1/1/22 for all gear, regardless of when actually issued.
- Last inspection date will be April 2022. Inspection intervals range from annual to monthly (PLBs).
- Make/model #s also are limited and may not be reflect what you have. If you contact me with corrections I can add a note.
- We've been asked to enter privately owned PPE -- with a note -- so that inspections can be tracked. Please contact me or Walt if you purchased any of those 7 items instead of using issued gear.
- Members can view and "accept" but not edit the other fields. Kindly let me know if corrections are needed.

 "Acceptance" will mean checking a box for <u>each gear item</u>. You can review/accept all but PLBs now. You will receive an email acknowledgement when you accept gear – whether you do it yourself or I accept for you.

I'd like to thank Ben, and RSS Officers Tom and Walt for the excellent work they've done keeping these records straight. During our training class that some of the other flotilla data managers lacked complete records of issued gear. COMO Laurer shared Ben's PPE inventory spreadsheet as a model of how to organize the information collected by RSS officers, or what inspection & maintenance is required for different types of gear. Thanks, gentlemen!

Other AuxData Tips & Reminders

- All Crew members should be able to use AuxData by the beginning of the boating season. See above. Individual training sessions are available just ask!
- Per ALAUX 012/22, you should log into AuxData monthly to make sure you aren't locked out due to inactivity. If that happens, please request your account be reset by sending an email to: Auxdata@acumensolutions.com
- When reporting Boat Crew training attendance (virtual or "shore-side")
 please use 99D. Only the instructor uses 06A for his/her teaching time and
 does NOT report your attendance.
- Attendance at instructor-led workshops such as TCT, Operations and many of the D-Trains will be reported by the instructor. If you're not sure whether it was, check your record...or ask!
- For online workshops with no instructor (such as VE, IT, etc.) you'll need to send me an attestation form if no certificate is supplied on completion. Ditto for non-Aux certificates such as CPR and Youth Protection Training.

Want initial AuxData or refresher training? Just ask! We can set up an individual session by phone.
