- PPE Rick Kunz:
 - Excess PPE being collected and will be stored at Station Oswego under supervision of Jim Middleton.
 - Rick will advise of arrangements to drop off excess equipment. Would like to meet halfway or otherwise reduce the traffic.
 - Advise Rick of PPE (and PLB) needs for Active OPS personnel and Trainees.
 - Steve Botsford advises that (Commodore) Bob Laurer has been assigned oversight of PPE at district level.
- OPS Rick Kunz:
 - Bob Laurer (District OPS) is working with Pam Wik Grimm on the Boat Crew training which may become a District wide program. Commodore Laurer "wants to get as many people on the water this year as possible."
 - Rick wants to hold a Division Wide OPS meeting with Station Oswego at Station Oswego in April 2022. This will be open to all OPS personnel.
 - Chain of Leadership and Management:

- o Rick said it must be respected (in both directions up and down). Flotilla issues must be taken to Division and not bypassing Division and going directly to District. Division will respect the chain going down to Flotilla level.
- Covid. There seems to be some confusion on this. Steve Botsford indicated that Auxiliarists are NOT required to get vaccinated but non-vaccinated members cannot participate as part of in person missions. Rick said underway hours were NOT waived for Operational Personnel by the 05 January 2022 Auxiliary COVID-19 Reconstitution Guidance, Version 3. Unless we hear differently, I think we should adhere to the 05 January 2022 guidance.

 - Division advises that Non-operational missions can be approved at the Flotilla Level.
 - Personnel wishing to perform non-operational missions are asked to request assignment to duty via email to Flotilla Commander (copy to Vice Flotilla Commander) as you have done in the past.
 - Flotilla Commander will respond to you promptly (VFC in FC absence) with Go or No Go on the mission. Missions in this category might include (but not limited to) Vessel Safety Checks, Dealer Visits, and other Missions not requiring Coast Guard Orders.
- Operations Update. Virtual Boat Crew Training begins (officially) on 12 February 2022. An additional first class (officially starting on 12 Feb 22) was held on 05 February 2022 for those who were unable to attend on the 12th.

Member Training Minute - Instructor

We hope you enjoy this new monthly column and possibly decide to earn a new qualification. I'm starting this series by focusing on the three pillars of Recreational Boating Safety:

- Public Education
- Vessel Examinations
- Marine Dealer Visits

Formal Public Education classes must be led by qualified Instructors. The Coast Guard Auxiliary Instructor training and certification program was re-written in 2020 to include new materials and techniques, including effective use of multimedia.

The certification requirements are:

- Complete the open book test (no proctor required) with a score of 90% or greater
- Complete PQS requirements with mentor
- Plan and present two Lessons

The Instructor candidate's mentor can use the materials provided to assist candidates from novices to skilled educators.

We need a team of skilled Instructors to lead our Public Education program. They're also required from many member training activities such as the annual Operations Workshop. The Instructor can be the subject matter expert or work jointly with a subject matter expert to effectively present material.

Please contact me or one of our current Instructors to learn more. It's a rewarding qualification and an extremely important component of our Recreational Boating Safety mission.

Changes in Virtual Auxiliary Classroom

USCG Aux National Training Directorate (distributed Jan 25 2022)

On 19 January 2022 the Auxiliary Online Classroom (https://classroom2.cgaux.org/moodle/) was rebuilt as New AUX Classroom.

Everyone is now a first time learner to this specific site and will need to create a new account using your Member ID, associated email address and a new password. Once a new account is created, you will be given access to the New AUX Classroom.

The New AUX Classroom requires all users to create a STRONG password with 10-characters, UPPER & lower case letters, numbers, and special characters. To better visualize, here is an example of a STRONG password: ABcdef12#\$

Another significant change is the way in which you register for a self-pace course. This is a part of our security upgrade. The new protocols require that every course have an extra layer of security at the course level. This is accomplished using *enrollment keys* for self-paced courses. An enrollment key is simply a 4-6 character code unique to each course that unlocks the course for individual learners.

Within the new AUX Classroom, there are now 2 types of enrollments.

- 1. **Manual Enrollment**: This is used for courses that have specialized enrollment criteria such as C-Schools or courses with limited enrollment. Learners will be enrolled directly by the course instructor.
- 2. **Self-Enrollment/Self Paced:** Any course open for self-enrollment such as Core Training, BQC2 or other courses that do not require an instructor. *For security purposes, these courses now require an enrollment key.*

Each Directorate is responsible for securely maintaining a list of enrollment keys associated with their self-paced courses. Each Directorate also has a special page on their WOW site called "Enrollment Keys", You can access enrollment keys using your Member Zone (MZ) password. A video showing the process is available to view after login to the New AUX Classroom.

Your access or password for the Member Zone (MZ) and for the National Testing Center (http://ntc2.cgaux.org/NTC/) have not changed.

A few other points of consideration:

- Due to the change over and enhanced security, prior enrollments and past learning history from the OLD AUX Classroom could not be rolled into the new system. Nothing transferred to the New AUX Classroom. Users will have to re-register for any self-paced courses they were engaged in prior to the transition.
- Any training completed in the old system and verified through the National Testing Center is safely recorded in AUXDATA. This includes Core Training and the Basic Qualification Course as well the AUXOP courses.
- Some old/outdated training content from multiple directorates were not transitioned to the new system because they were unable to run in the new secured system.
- Certain other valid training courses transitioned to the new system but are hidden for now while they are being updated. Once complete, they will be available again.
- Users enrolled in self-paced training can re-enroll in the same course within the new system. Unlike the old system the new system can track user progress and even generate certificates of completion.

Like any transition, this one is not without a few challenges. But once we make it out of the inlet, it will be fair winds and following seas as we take the Auxiliary into the future.
