From the Helm

Greetings, Shipmates!

I thought I might comment a bit on the wear of uniforms while representing the United States Coast Guard Auxiliary and in the

performance of our Auxiliary duty, the US Coast Guard itself.

The "uniform of the day," (UOD) is defined by most sources as the designated uniform all military personnel are required to wear on that particular day. It is often designated by the senior officer on the base. What that means is that everyone wears the same designated uniform while on duty. As an old military guy, I have always subscribed to the uniform of day concept, the proper uniform, worn properly, and the wearer is clean and squared away. I am reminded of the old pseudo acronym STRAC. STRAC = "Skilled Tough Ready Around the Clock." Needless to say, there are several variations of STRAC, most of them actually clean language, too, but they all basically mean the same thing.

So how does UOD apply to the Coast Guard Auxiliary? The Auxiliary is a uniformed nonmilitary force and we wear a Uniform similar to the Coast Guard and as mentioned we represent them. Often the civilian world can't tell the difference so to them we ARE the Coast Guard. We are therefore expected to wear our uniform in a squared away manner whenever we are on duty.

Personally, I favor the Operational Dress Uniform (ODU) for most of our (Non-Dress Uniform) duty. It is the Coast Guard Auxiliary's utility uniform, is sharp looking, comfortable, and rugged.

That said, there are some considerations with regard to Uniform of the Day and some flexibility must be allowed:

 Some members because of physical reasons may not be able to wear the ODU. They should wear an alternate authorized uniform such as the Tropical Blue Uniform ("Trops").
 Some mission-specific duties allow for an alternative uniform such as Vessel Examiners and Culinary Assistance Personnel.

Whatever uniform we wear, wear with pride and wear it properly. Refer to Chapter 10 and other sources for information on Auxiliary uniforms. Don't hesitate to ask senior members or the Flotilla leadership for tips on proper wear of the uniform.

I am proud to say that Members of this Flotilla understand the need to present a positive image of the Coast Guard when on duty. You all wear it well and wear it with pride.

This month we're focusing on a second pillar of Recreational Boating Safety – Marine Dealer Visitor. Auxiliarists attempt to get our Boating Safety message to the public in many ways, including:

- Direct interaction with boaters through:
 - Boating Safety Classes (featured in February)
 - One on one discussions during Vessel Examinations (see April's article)
 - Information tables at events such as Treman Safety Day, Ithaca Fishing and Conservation Day, CNY Winter Boat Show, and the New York State Fair.
- Indirect interaction through:
 - Boating safety literature displays at marinas and other venues frequented by boaters
 - Outreach through news stories and social media, such as Facebook



As you may guess, Marine Dealer Visitors (MDVs) duties are focused on sharing our boating safety message through marinas and businesses that sell or rent boats and associated gear (e.g., fishing tackle & bait, life jackets, etc). In central New York, the prime season is typically April – September, since most of these businesses are closed or focused on other activities the rest of the year. The certification requirements are:

- Complete the open book test (no proctor required) with a score of 90% or greater
- Participate in 2 Marina Dealer Visits with a certified Marine Dealer Visitor

The test is a little tricky, but can be re-taken if necessary. The actual duties are straight forward and very flexible as to timing and frequency. BTW, Program Visitor (PV) is just another name for a Marine Dealer Visitor.

Please contact Kim, Jen or one of our current MDVs to learn more. It's a fairly simple, but rewarding qualification, and an extremely important component of our Recreational Boating Safety mission.

CPR and First Aid Online Training Update

Part of the D-Train class discussions this month included the Auxiliary's policy on CPR and First Aid. I wanted to share the general consensus as some of our members expressed an interest in recertification through online training.



The following summary reflects my personal understanding of the current situation. *I am NOT a lawyer, policy expert OR doctor!*

- First, there have been no recent updates to the official policy which states that training must be hands-on. (2006 ALAUX Subj: CPR and Use of AEDs Jan 9 2006 <u>https://help.cgaux.org/index.php?/Knowledgebase/Article/View/147/1/cpr-and-use-of-aeds</u> states in part that training must be in-person. "The next change to the Ops Policy Manual will more clearly address this subject and will prohibit the use of online training for certification in CPR and AED use. Training must be hands on.")
- Both American Red Cross and American Heart Assn offer hybrid training which lets you complete the first part online, then follow up within a specified period (90 days for ARC) with an in-person "skills session." This is acceptable to the Auxiliary. ARC is at https://www.redcross.org/take-a-class/classes/adult-first-aid%2Fcpr%2Faed-online/a6R3000001vqDD.html and AHA at https://cpr.heart.org/en/.
- Please use due diligence when dealing with competitors selling online-only CPR courses which claim to be ARC or AHA "compatible" or "nationally recognized" or "OSHA-compliant." Online CPR / First Aid classes are worthless unless you receive a certificate which is recognized.
- Once you have completed the skills session and have your certificate, please send me a photocopy or scan so it can be added to your AuxData record.
