We have completed the first training on the Aids Verifier PQS. Three people have been qualified, two from our flotilla and one from 35-06.

The DSO-MT is emphasizing the AUXLAMS Part A on September 12 and Part B on September 26 to be presented in Lisle. You will need a Short Term Training Request (STTR) for possible funding for this. It has a deadline of June 3 for getting the paperwork to the District Commodore. National has stated that there will be no C-school orders issued after July 31 for the current year.

The Mandatory Workshop for VE Currency deadline is June 30.

As we studied the Light List, Jan noticed a discrepancy for the buoy marker off 12th Street Beach (Northerly Island Danger buoys). The Light List had its location at 51 degrees North, when it actually is 41 degrees North. The necessary correction was submitted up the chain and the paperwork was filed.

At the present time Division 35 has been tasked with ATON checks for the upcoming boating season. There are 12 Class I PATONS and 12 Class II PATONS for us to check on once the weather allows us to be on the water.
