Boating season is coming to an end. Please check that you have adequate activity to maintain your currency. It's getting late if you need a check ride! Are all your underway hours showing up in AUXDATA? That's what counts. Be sure to check it out.

Have you checked your <u>emergency contact information</u> in the AUX Directory? Is it up to date? You never know when you'll need it, or better put, when <u>someone</u> else will need it to help you in an emergency. The Auxiliary is part of our extended family that we don't even think about. For example, we had a member who had a problem that incapacitated him. The person who found him knew he had a boat in one of the Chicago harbors, so she contacted the Harbor Master. The Harbor Master knew he was a member of the Auxiliary and passed on an email address for someone in the AUX that was a contact for Vessel Exams. Within hours Station Calumet Harbor was called and they were able to access Emergency Contact information through contact with the Auxiliary. After all of that effort, the person had no information on file. So friends were contacted who might have any information. This was a near death emergency that fortunately had a good ending. But will YOU be so lucky? Update it now!
