There are four distinct programs under Navigational Systems:


- Aids to Navigation Verification

To perform ATON Verifications, members must complete the National PQS (available on the Internet at <u>http://wow.uscgaux.info/content.php?unit=P-</u>

DEPT&category=aids-verifier-pqs

(Verifiers who previously qualified under the Ninth District qualifications needed to recertify every three years. Those certified in 2010 or 2011 will be grandfathered for 2013. As of 2012, the National Personal Qualification Standards (PQS) replaced the D9 qualification.)

To report discrepancies, or to submit chart corrections, NO SPECIAL QUALIFICATIONS are required. The reports are submitted through your NS staff officers to the appropriate agencies to help them.
