Shipmates let me share with you that under the terms of the Fair and Accurate Credit Transactions (FACT) Act of 2003, the three nationwide credit reporting agencies must establish a centralized source for consumers to request and obtain a free copy of their credit report once every 12 months.

In order to request a copy of your credit report, you can login to the dedicated web site www.AnnualCreditReport.com, or call the toll-free telephone number 1-877-FACTACT (1-877-322-8228). Their postal address is: Annual Credit Report Request Service P.O. Box 105281 Atlanta, GA 30348

Further, the credit reporting agencies must provide the consumer with his/her requested credit report free from charge within 15 days of receiving the consumer's request. Additionally, any disputes raised by the consumer must be reinvestigated within 45 days of the consumer's dispute. Moreover, you can request a copy of your credit report from any of the credit bureaus provided

Grand Haven CG Festival is Challenging and Fun for Auxiliarists Phil Aszling SO-PE

Few will dispute the feeling of Western Michigan's Auxiliarists that supporting the Grand Haven Coast Guard Festival falls first to them (especially Grand Haven's own Flotilla 31-05). But many Auxiliarists are needed to help this Festival run smoothly, and 31-05's Joe Sedlock, the Auxiliary's Liaison to the Festival, welcomed those of us from "Across the Lake" who went to Grand Haven this year, from 27JUL to 5AUG. For DCDR Tom Mulally (35-07), SO-PA Ruth Aurigemma (35-07), and me (SO-PE, 35-06), working the Festival was a challenge and a lot of fun.

Although there were a good dozen events that Auxiliarists worked (including Coastie), we really made a difference in supporting the Gold Side by assisting with the tours of visiting ships – which allowed most of their crews to go ashore for some rock & roll, corn dogs, and elephant ears. Joe Sedlock reports that the three attending cutters (USCGC *Hollyhock*, USCGC *Neah Bay*, and Canadian CCGC *Griffon*) hosted "a total of 24,435 visitors, including one dog and one monkey" during the ten days of the Festival.

Typically, three Auxiliarists worked each ship for each twohour public tour. One admitted and counted visitors at the gangplank, boarding as many folks as exited the ship minutes before. Another worked on the foc'sle, boat deck, or fantail as needed. The third helped out on the bridge. A couple more Auxiliarists for each tour would have been very helpful. For example, visitors tend to linger on the bridge. Of course! It's full of electronic wonders and provides a fascinating opportunity to chat with a bosun's mate or petty officer who actually drives the ship. Frequently, the bridge was packed to the bulkheads, and the Auxiliarist had to placate visitors who came up from the boat deck. Furthermore, the watertight door to the bridge has a very high threshold, that visitors trip over; and the companionway ladder off the bridge to the deck below is extremely steep. Two Auxiliarists on the bridge could benefit greatly, freeing the BM or CPO to fascinate the visitors. Similarly, two Auxiliarists to work the waiting line at the gangplank would help. It can include up to a thousand visitors, eager to go aboard, if only 20 to 50 at a time.

This is a wonderful opportunity for Auxiliarists to "sell" the people in line our programs: VE's, membership, and above all boating-safety courses. (Bring those 9thWestern business cards!)

Next year's Grand Haven Coast Guard Festival is scheduled for Friday 26JUL to Sunday 4AUG. Come if you can; the more Auxiliarists, the smoother the Festival will go. Check with SO-PA Aurigemma about arrangements, and sign up early, because hospitality resources get scarce. And when you're not on duty, have fun exploring the area, from Holland to Ludington. It's about as "pure" as "Pure Michigan" gets!
