

With the end of the boating season approaching, Division 35 will resume weekly training on Saturdays - beginning 20 OCT at 1000 - at the Mead training room, 1450 E.  $98^{th}$  Street (about 3 miles west of the Coast Guard Station). Initial topics will be:

The global e-commerce business that gives its account holders the ability to accept and send payments via the internet from your bank account and credit card is PayPal. PayPal will hold your money designed to your PayPal account. Your held money will not earn interest directly from PayPal and it is not FDIC insured directly under PayPal.

"PayPal is an acquirer, performing payment processing for online vendors, auction sites, and other commercial users, for which it charges a fee. It may also charge a fee for receiving money, proportional to the amount received. The fees depend on the currency used, the payment option used, the country of the sender, the country of the recipient, the amount sent and the recipient's account type. In addition, eBay purchases made by credit card through PayPal may incur extra fees if the buyer and seller use different currencies."

PayPal is a Palo Alto, California based company money transmittal service that enables you to pay for purchases, send money to others and accept payments from others without revealing your financial information.

Note:

"PayPal does not physically handle or hold funds placed into the PayPal service and as long as we continue doing what we are doing today, we won't be subject to Federal banking laws," said PayPal Chief Executive Peter Thiel. However, State regulators will make their own determination under state law about whether PayPal is acting as a bank.

Several state authorities in their review of whether PayPal is engaged in the business of banking under state law is still under review. Paypal has actively pursued licenses to operate in states that have questioned their operations where a state money transmittal service license is required.

PayPal does not lend money and may not offer the depth of protection services, as does your bank credit card. One must read the protection services user agreements to find the differences between your bank credit card and Paypal.

"PayPal has started depositing customer balances into FDIC-insured bank accounts. The company had asked for an opinion from the FDIC on whether it could pass the insurance protection on to its customers. In its advisory letter, the FDIC said the insurance protections up to \$100,000 per customer per bank would extend to PayPal customers, even when PayPal deposited the funds for them."

Some Information about Paypal Fees and services:

Buying something

Transferring money always free - PayPal is free whenever you use it to buy something or make a payment in the US. The seller pays us a small fee to securely handle your payment. As a buyer, you never pay a fee to use PayPal.

Selling something

Small Fee - PayPal fees mainly apply to sellers, who pay a 2.9% transaction fee on the total sale amount plus a \$0.30 fee per transaction. There are some exceptions, listed below. If you have a business, see PayPal Merchant Fees for discounted rates and other pricing info.

Transferring money is usually free except there is a small fee for international money transfers.

Sales within the US:

2.9% plus \$0.30 per transaction.

Discounted Merchant Rate:

As low as 2.2% based on volume.

Discounted Rate for Eligible Nonprofits:

As low as 2.2% based on volume.

International Sales:

3.9% transaction fee plus a fixed fee based on currency received.

PayPal Here<sup>TM</sup> card reader:

2.7% when you swipe a card. 3.5% plus 0.15 per transaction when you type in a card number.

PayPal balance or bank account:

Free when sending money inside the US.

Debit/Credit card fee:

2.9% of total amount sent plus 0.30 per transaction (the sender decides who pays this fee).

Outside the US:

Small fee of 0.5% to 2% (depends on destination) when fully funded with bank account or PayPal balance. 3.4% to 3.9% if paying with a credit or debit card."
