

FLIGHT ON COAST GUARD AIRCRAFT

On Thursday, 12 March 2020 Rick Rutherford, John Hardin (Flotilla 3-5) and Don Anderson had the opportunity to ride along on a training mission on a Coast Guard CJ-27 out of AIRSTA Sacramento. They lifted off from the McClellan airstrip enroute to Half Moon Bay to conduct training with the CG Cutter Tern. The plan was to air drop a dewatering pump to the underway cutter. However, due to only 15' visibility on the ocean surface due to fog the intended mission was canceled. The aircraft then flew over the fog cover outside of San Francisco Bay and practiced search patterns and a simulated air drop.
