Dee Walter, Jim Kremsner and Leon Borden manned 3 PWCs while Tom Komadina, Keith White, Pat Walter and Robin Morgan crewed Reno Boat Facility Following Sea. Coast Guard Boat 578, a Placer County Sheriff's boat with diver and Flotilla 1 members on the dock helped ensure the safe passage of this event. Falling in this cold of water rapidly causes skeletal muscles to become immobile, long before hypothermia sets in.
