ment at our NACON 2011 meeting on August 11, 2011: to jointly promote Recreational Boating Safety (RBS) – In 2010 there were over 12 million registered boats in the United States, plus many more that were not registered. During 2010 the U. S. Coast Guard recorded more than 4,600 boating related accidents resulting in 672 deaths, 3,153 injuries and property damage of over \$35 million. The majority of these accidents involved boats operated by individuals who had received no boating education. We clearly have a lot more work to do in educating the boating public.

Our new memorandum of understanding will address three main areas where our current activities overlap.

- Vessel Exams and PV Involving interchangeable training, joint workshops, & coordinated locations for VE's and PV's.
- 2. RBS manpower Having more members involved in this area & focusing on introducing new members to this area, along with encouraging older, inactive, members to participate in the RBS mission.

3. Recruitment: Both of our organizations represent the two largest U. S. Boating education organizations, but we are a small part of the whole boating community. We need to plan some joint community outreach programs & develop material that can jointly promote both the USPS and Auxiliary.

I believe that the above goals are realistic and make good sense to utilize our collective talent and knowledge to make a deeper impact on the boating community. I will hand out copies of this memorandum at our next meeting.

On October 15th 2011, Flotilla 19 held a course taught by women for women – "Suddenly In Command". It was well attended by the local community, including several women from Canada.

The object of the class was to provide women with knowledge to help them become safer and more confident boaters. The class was taught by instructors from Flotilla 19 and Flotilla 11.

A total of 15 students and six Auxiliarists were in attendance.

The class ran from noon until 4:00 and topics of discussion included Being Prepared; Know your Boat; Emergency situations and how to deal with them; Rules of the Road; Man Overboard; Communications and handling/tying lines.

Various hands-on demonstrations were presented including inflating a life vest, practicing communications and line handling on the Auxiliary Facility "Challenge".

We were pleased to have Coast Guard Petty Officer Lydia Miller from Station Bellingham join us for the afternoon session.

Positive feedback was given by the group and we left them wanting to learn more!
