NOTE: This information is publicly available on the website, so **no password is needed**. Once you have a draft of the application completed, contact Mark Salopek

NOTE: If you have passed a boating safety course or its equivalent, you'll need to certify that on the application also. Some items that get the application kicked back at the next level, may be not listing anything for blood type...if you don't know, list it as 'unknown'....or not putting in full names of parents, and making a copy of any documents that you are using as proof of citizenship.... acceptable documents are listed in the application. As far as dues are concerned, your Flotilla likely won't collect them until you show up on the roster, because the amount is prorated by quarter.

Step #5 Core Classes:

AUXCT Course Requirements: As a result of these changes, AUXCT is now comprised of the following repeatable and one-time courses:

a. Repeatable Courses: To be successfully completed by the end of the first full year of enrollment and then once every five years thereafter:

- (1) Workforce Resilience Training (502379)*
- (2) Security Fundamentals (810030)
- (3) Privacy at DHS: Protecting Personal Information (810015)
- (4) Sexual Harassment Prevention (810000)
- (5) Civil Rights Awareness (502319)

* Auxiliarists who have yet to complete AUXCT because they had not completed the Sexual Assault Prevention / Response course (810045) must now complete the new Workforce Resilience Training course (502379). This holds true even if they already completed the Building Resilience and Preventing Suicide in the Coast Guard course (502379) because the new version now contains material from the old Sexual Assault Prevention / Response course (810045).

b. **One-time Courses:** To be successfully completed only once (new enrollees must complete them by the end of the first full year of enrollment):

- (6) Ethics 1 / Personal Gifts (502306).

And the recently added:

- (7) Basic Qualification Course II (BQC II)** **This BQ Course can be found on the Auxiliary training web-site: Click on the link for "Basic Qual II Course" on the left side of the page:**
