Vessel Examinations—Josephine County

Then, we will visit one state boat ramp, perhaps 2 Army Corps of Engineers' ramps, and as many as five Jackson County Ramps, depending on the number of shipmates who sign up.

Grants Pass Fire Rescue—ON THE WATER!

Far too often in the summer you will see a person floating in an innertube, no PFD, and a beer in both hands. No wonder rescues are needed and within the city, rescues are conducted by GPFD.
