- a. Additions or comments to Flotilla Staff Officer Reports none
- b. Upcoming Events/Great Northeast Boat Show VFC Grossi reported for FSO-VE Jamieson that helpers are needed for the 21 MAY House at Station Portsmouth Harbor from 0900-1400. Volunteers should report at 0830. FSO-VE Jamieson has requisitioned Coca Cola to make 2 banners, which will be flown at New Castle Common and the entrance to Station Portsmouth Harbor to announce the event.
- c. Maine Ice Patrol With the enhancement of an excellent digital presentation, LO-AV Hewitt delivered a most interesting and informative overview of the AUX AIR program. A private pilot for 35 years he has been involved with the Auxiliary's Air Program for the last 10 as Air Crew. Of particular support to the Gold Side the AUX Air wing is greatly appreciated because they are able to "fly low, slow and cheap"!
 - Some of the many things they do to support the Coast Guard include: AOR Patrols for fire, boaters in distress, suspicious activity, oil spills and/or other environmental hazards, obstructions to navigation, safety/security, monitoring of marine life, ice patrols, photo documentation of vessels, SAR cases, and special tasking, sometimes with/for other agencies. Interested members are encouraged to speak with LO-AV Hewitt for more information.
 - FSO-MT Heath asked about the possibility for joint evolutions between surface and air operations for the 2016 season.
 - BM3 Richey asked if the Gold Side could partner to give break-ins AOR familiarization flights.
 - LO-Air Hewitt will follow-up on both questions.
- **d.** Communications Web/Email update FSO-CS McAndrew said the email list is being updated with particular focus on adding break-ins and removing others who are no longer members. He continues to make progress in this effort.
- e. OPFAC report and awaiting Cutter Orders -
