PROGRAMS OF NOTE:

PE has the following classes planned:

- Boating Skills and Seamanship will be offered as part of the York Adult Education Program beginning on September 15. Publicity for this course has begun with distribution of posters to libraries, town halls, marina and post offices in the York-Kittery area. Newspaper and Internet publicity will be completed in August.
- How to Read a Nautical Chart will be offered as a 5 hour, two-night course in the Wells Ogunquit Adult Education program in October. If the registration exceeds our maximum of 10 (space needed to spread out the charts) the course will be repeated in November.
