The Influenza and Ethics Training must only be completed once; while the other six courses must be completed once every five years. New members should complete all 8 courses in their first year of enrollment.

Diversity in the Auxiliary

Ask any five members of the U.S. Coast Guard Auxiliary what "diversity" means and you are likely to get five different answers. Interestingly, you're just as likely to find all five answers are correct (at least in part). Most Auxiliary members will mention diversity in the culture, ethnicity, age and background of current and prospective members – and they would be right to mention these characteristics of diversity. But there is more to diversity than just the sum of our members' traits.

There is more to the concept of diversity than simply acknowledging our differences and then seeking to include them within our organization. Instead of simple inclusion, we should seek to leverage these differences for productive gain. An excerpt from the Diversity Directorate's website introduction plainly states:

"Diversity is about acknowledging differences and adapting practices to create an inclusive environment in which diverse skills, perspectives and backgrounds are valued. It is about understanding the individual differences among our members that arise from a broad range of backgrounds and lifestyles, and recognizing the value of using those different perspectives and ideas to enhance the quality and outcomes of our mission."

Said in another way: We should recognize, understand, and use to their best advantage, the differences in our membership.

And while it is true that the skill-sets, education, experiences, and talents of each individual member should be employed to improve mission outcome; the same philosophy of diversity should be applied to our business paradigms. That is, think and act with a diversity mindset. As you prepare to undertake a given mission, think, "Can this be done differently?" This is an especially helpful approach when confronted with barriers that limit our

effectiveness. Diversity isn't found in just the way we look, or where we come from, or how we were raised – it is also present in how we think. A diversity of thought, when put to good use, can achieve remarkable results.
