**1941:** FC Tom Clarke's continuing remarks and recognizing those with input on various topics e.g. Chris Houlihan advised on Boat Crew certification, swim test once per year.

### Continuing member input

- -John Mellen remarked on "best time to achieve Radio Facility approval", and must be TCO qualified. John M. announced he is presently training for watchstander.
- -Paul Maglio & John Mellen discussed paying \$ cash for meals during training at Station Gloucester.
- -Ally O'Connor suggested for the Boat Crew Manuals for sale on Amazon, make sure they are the latest version.

#### 1955: New Business

FC Clarke announced that he informed Station Gloucester for various Auxiliary contacts (e.g. PE, VE, etc.)

- -Chaplain Floyd Grace is deployed on assignment.
- -FC Clarke also announced that the Flotilla has positions open for FSO-NS & FSO-OP.
- 2000: John Keyes requested feedback regarding PA events for 2023.
  - -David Swensen and Ally O'Connor touched on Gloucester 400 events.
  - -Ally O'Connor reminded us about the annual Schooner Festival, & also that the local American Legion Post 3 (old Gloucester City Hall) monthly breakfast is open to the Active Duty CG as well as the Auxiliary.

Also mentioned, auxiliarist not required to be a veteran.

FC Clarke asked about member personal skills that could possibly assist the Active Duty Coast Guard.

Chris Houlihan touched on financial advice (e.g. setting up one's bank account, to acquire a notary, cpa, etc.)
