## **CONDENSED VERSION OF REPORTS/MOTIONS**

Minutes of meeting on 04Jan2021 approved by motion.

**FSO-PE** reported that SUNY-Adirondack will not be allowing students to pick up materials, so we must send the materials. We are permitted to use old books and Power Point until June. Presently we have 2 students signed up for the April 10<sup>th</sup> Class. Although we may cancel if we have less than 8 students, after discussion it was agreed to lower the acceptable number to 6.
