Condensed Version Of Reports/Motions: Minutes of meeting on 01-Feb-2021 approved by motion.

Advised that Facility inspections now must be entered into Auxdata II, so it is important to attend the Workshop to learn the procedure. Further advised that Enny has the 2021 VE stickers.

DV Will submit the application for the 2021 NACO award. Plans on having a diversity workshop at a Flotilla meeting in the future.

PE We now have 4 students registered now Instructor schedule is completed. Further reported that she and other instructors took part in the electronic "Conducting a Virtual Public Education Course" session on 25-Feb, and that due to the testing requirements, we may have insurmountable issues conducting/completing the class with ACC. Discussion ensued concluding in the thought that we should conduct a practice session before the April class.

Slusher advised that he continues to look for the standing rules for the Flotilla and the Division.

Remarks: (Awards/Special Events/Future Plans)

FC advised that the Annual TCT refresher will be in May. She will send an email regarding Core Training that may need to be updated before the end of the year.
