ORDER of BUSINESS

PRELIMINARY MATTERS (encompassed 1815 - 1840h)

- At 1815h DCDR called the meeting to **order** and led **Pledge of Allegiance**; 16 in attendance. Of note: The DCDR provided an American Flag flown over the United States Capitol in 1993. Also in the function room with us was the "Center Stage Dance Company" of young people. Observing our Pledge, they immediately stood and pledged with us. Others in the diner on the other side of the glass also stood and pledged. This respectful expression of patriotism was warmly appreciated by all Auxiliarists and our respectful gratitude shared.
- DCDR welcomed **DCAPT Gene Yetter** who was the only out-of-Division **visitor**. DCAPT said it was always a pleasure to be with DIV15 and commended DIV15 for being among the first in Sector NY-N to return to an in-person meeting format. Fellowship, one of the Four Cornerstones, is important to getting back into the groove. He encouraged those with questions about what constitutes a "squared away" uniform to ask those in their COLM. It's been an extended hiatus and we need to prepare for uniform inspections and look as well as act in keeping with the standards of the United States Coast Guard Auxiliary.
- On motion of TOWNSEND seconded by NYE, **Q1 Minutes** of the 29 March 2022 Division 15 Meeting were accepted as submitted by SO-SR. Unanimously voted.
- On motion of TOWNSEND seconded by NYE, **SO-FN Brown's finance report** was accepted as submitted by SO-FN. Unanimously voted.
- The DCDR then gave his remarks beyond his written report. The tunnel is getting shorter, the light is getting brighter, and in fact we're here together in person, so we're out! Still stay safe, stay responsible. Use Update #10 which is a GAR rubric. Remind ourselves we are a strong force for good, resistant and resilient. Know when to reach out: use the buddy check to ask, be compassionate, and refer to address questions and solve challenges. These are little notes the DCDR keeps visible. He encouraged all to consider a note of our own to keep in focus. The DCDR then read a note to DIV15 from the family of Dorothy Hinds and led all in observing a moment of silence for those we have lost. (John Hinds has since requested 5 patrol orders!)
- 6 **IPDCDR** expressed how good it is to be face to face again. Operations are doing well, and we are back on the water, including a number this weekend in aid of the Burlington fireworks.
- 7 **Roll Call** was accomplished at sight. Meals were then served during a break from business lasting from 1840 1905 h.

BY DCDR:

- DCDR created and sent a **uniform inspection** form to FCs who need to conduct the inspections and retain a dated copy for each member in their Flotilla records.

- This summer: pursue inactive members: "Where do your AUX interests lie? How do you want to serve in the USCGAUX?" Consider possible changes to status including transfer to a Flotilla in their new home area; Retired status; disenrollment. Start these conversations early.

- DCDR provided **awards folders** to each Flotilla present. On motion by TOWNSEND, second by NYE, and unanimous vote, years of service awards will be acknowledged at Change of Watch. DCDR will mail awards folders to those Flotillas not represented in person at this meeting.

- DCDR noted D1SR election will occur at D1SR meeting at **D-Train 8-11 Sept 2022 Stamford, CT**.
- DCDR appointed Lynn Enny, Lee Townsend, and Terry Tremblay as DIV15 election screening cmte.
- DCDR **thanked JIM CANAVAN** for being with us tonight and for his expertise and generosity which resulted in the **DIV15 radio antenna purchase** (with cables, adapters, tripod, etc.), budgeted as a \$600 expense, instead costing only \$280. DCDR will host the equipment at his home.
