


a decal for that year is

# **ABOUT BOATING SAFELY**

This beginner boating class will give you the knowledge needed to obtain a boat license or safety certification in many states. Many boat insurance companies will offer discounts on boating insurance to boaters who successfully complete About Boating Safely.

#### **TOPICS INCLUDE**

- **Introduction to Boating** Types of power boats; sailboats; outboards; paddle boats; houseboats; different uses of boats; various power boating engines; jet drives; family boating basics.
- Boating Law Boat registration; boating regulation; hull identification number; required boat safety equipment; operating safely and reporting accidents; protecting the marine environment; Federal boat law; state boating laws; personal watercraft requirements.
- **Boat Safety Equipment** –Personal flotation devices ("life jackets"); fire extinguishers; sound-producing devices; visual-distress signals; dock lines and rope; first aid kit; anchors and anchor lines; other boating safety equipment.
- Safe Boating Bow riding; alcohol and drug abuse; entering, loading, and trimming a boat; fueling portable and permanent tanks; steering with a tiller and a wheel; docking, undocking and mooring; knots; filing a float plan; checking equipment, fuel, weather and tides; using charts; choosing and using an anchor; safe Personal Water Craft (PWC) handling; general water safety.
- Navigation The U.S. Aids to Navigation system; types of buoys and beacons; navigation rules (right-of-way rules); avoiding collisions; sound signals; PWC "tunnel vision."
- Boating Problems Hypothermia; boating accidents and rescues; man overboard recovery; capsizing; running
  aground; river hazards; strainers: emergency radio calls; engine problems; equipment failures; carbon monoxide
  (CO); other boating and PWC problems.
- Trailering, Storing and Protecting Your Boat Types of trailers; trailer brakes, lights, hitches, tires, and bearings; loading, balancing, and towing a trailer; towing, backing a trailer; boat launching and retrieving; boat storage, theft protection; launching, retrieving and storing a PWC.
- Hunting and Fishing, Water-skiing and River Boating Carrying hunting gear and weapons in a boat; fishing from a
  boat; water-skiing safety guidelines and hand signals; water-skiing with a PWC; navigating rivers, and other boating
  tips.

A series of 8 hour, one day classes (from 8 am to 5 pm) will be provided at:

- Goodwin College, Rm. 311, Main Building, 1 Riverside Dr., East Hartford, CT on 3 Saturdays: March 22, April 26 and May 17<sup>th</sup>, 2014
- U.S. Coast Guard Academy, New London, CT on 3 Saturdays: March 15, April 12, and May 17<sup>th</sup>, 2014.

Classes run from 8 am to 5 pm, About Boating Safely books will be provided to each student. Please bring a lunch, pencil and pen. Upon successful completion of the class the student will receive a U.S. Coast Guard Auxiliary Certificate of Completion.

The cost for the class is; \$75.00 for individuals, \$65.00 for each additional family member taking the class at the same time and \$45.00 for students and faculty of either Goodwin College or the U.S. Coast Guard Academy (must have student ID to show the class instructor).

# **One-Day Boating Safety Courses begin in East Hartford and New London**

The U.S. Coast Guard Auxiliary will offer classes in *About Boating Safely* at two locations- Goodwin College in East Hartford and the U.S. Coast Guard Academy in New London. Classes at Goodwin College are held on Saturdays- February 22, March 22, April 26, and May 17. Classes at the Coast Guard Academy will also be on Saturdays February 15, March 15, April 12, and May 17.

This 8-hour-long, beginner boating class and test qualifies a participant to obtain a Connecticut Safe Boating Certificate, which anyone must obtain to legally operate any size boat with a motor in Connecticut waters.

Classes are taught by qualified Auxiliary members. The one-day classes are held at Goodwin College, Main Building, Room 311, 1 Riverside Drive, East Hartford and at the Coast Guard Academy in Yeaton Hall, Room 129, New London. All classes are from 8 am to 5 pm.

Course textbooks will be provided. Students should bring a lunch, pencil and pen. Those who successfully finish will receive a U.S. Coast Guard Auxiliary Certificate of Completion.

The cost is \$75 for individuals, \$65 for each additional family member taking the class at the same time and \$45 for students and faculty of Goodwin College with identification.

Topics include: Introduction to Boating; Boating Law; Boat Safety Equipment; Safe Boating; Navigation Boating Problems; Trailering, Storing and Protecting Your Boat; navigating rivers and other boating tips.

# On Saturday July 5, 2014, Get a Free Vessel Safety Check

Hartford – The Coast Guard Auxiliary has partnered with the Riverfront Recapture Rangers to offer boaters free vessel safety checks. Safety checks are designed to ensure your boat is in compliance with local, state and federal laws. If the boat does not pass the exam no citations, fines or penalties are issued. A decal is awarded to display if the vessel passes the examination.

Vessel safety checks generally take about 15 minutes and will be held on Saturday, July 5<sup>th</sup>, 2014 from 9:00 am to 4:00 pm rain or shine at Riverside Park, Hartford, CT. No appointment is necessary.

An example of some of the items checked includes:

- Life Jackets
- Registration and numbering
- Navigation lights
- Ventilation
- Fire extinguishers
- Distress signals (flares, horn, etc.)
- Battery cover and connections

# Coast Guard Auxiliary nears 75 years of service to the United States

On June 23, 2014, the Coast Guard Auxiliary will celebrate 75 years of service to the United States. The 31,000-member force has been lauded by Coast Guard Commandant Adm. Robert Papp as "the world's premier maritime volunteers." Here is a brief history of the organization.

Prior to 1939, there was no United States Coast Guard Auxiliary — not as we know it today. Instead, unorganized groups of volunteers who owned yachts, pleasure, craft and fishing vessels kept a watchful eye on the coastal and inland waters while they worked or cruised. These groups, mostly men, often looked for ways to assist the Coast Guard.

One thing that plagued these volunteer groups, and the Coast Guard, was that most members had no formal training in boating safety or the rules of the water. Accidents involving vessels, injuries and fatalities were rampant.

Then, in the summer of 1934, a yachtsman by the name of Malcolm S. Boylan and a Coast Guard friend, Lt. F.C. Pollard, began a discussion about ways to reach the boating community.

They drew up a letter outlining how a "reserve" made up of community volunteers could assist the Coast Guard in teaching boating safety and helping keep the waters safe. That letter made it to the desk of Cmdr. Russell Waeshe Sr. in Washington, who thought the idea was brilliant but lacked the clout to push it through. A great idea almost faded into history.

However, in 1936, Cmdr. Waeshe was promoted to rear admiral and appointed Commandant of the Coast Guard. Taking advantage of a number of influential friends, he succeeded in persuading Congress to pass the Coast Guard Reserve Act. This happened on June 23, 1939. Briefly, in order to: " (a) *Promote safety to life at sea and upon the navigable waters*, (b) *Improve efficiency in the operation of motorboats and yachts*, (c) *Promote a wider knowledge of, and better compliance with, the laws, rules, and regulations governing the operation and navigation of motorboats and yachts*, and (d) *Facilitate certain operations of the Coast Guard, there is hereby established a United States Coast Guard Reserve...which shall be composed of citizens of the United States and its Territories and possessions...who are owners (sole or in part) of motorboats or yachts...."* 

Unlike the Army and Naval Reserves that were made up of trained World War I veterans, the Coast Guard Reserve would be made up of civilian volunteers. They would not wear any uniforms, hold any rank, "or be vested with or exercise any right, privilege, power, or duty vested in or imposed upon the personnel of the Coast Guard." Rather, they were invited to place their private vessels at the disposal of the Coast Guard and assist with parades, and regattas with the understanding that, when their vessels were used, someone from the Coast Guard would take over as coxswain until the exercise was complete. This newly formed organization was not to be funded by the United States government; however, fuel was provided during use of personal vessels. Many were skeptical as to how effective these "reservists" would be but, with war looming on the horizon, that would soon change.

On February 19, 1941, Congress restructured the Coast Guard Reserve into the Coast Guard Auxiliary. Still basically called the Reserve, it was broken into two categories. The *active reserve*, made up of members who had to undergo stringent physical fitness demands, were paid and often sent anywhere the Commandant deemed their presence was needed. The *temporary reserve* remained community volunteers between the ages of 17-64, had no physical requirement, stayed within their communities, and did not receive any payment. Most of the new auxiliary members were recruited for the *temporary reserve*.

By the summer of 1941, area Coast Guard commanders had many Auxiliary vessels at their disposal for coastal patrols. With the coastal waters in need of protection and half the Coast Guard vessels out to sea, Auxiliary vessels made good patrol crafts. As a defense in case of enemy attack, the Coast Guard provided the Auxiliary with Lewis machine guns, Thompson sub-machine guns, rifles and pistols.

In 1942, several German U-boats were sighted off the East Coast and Auxiliary and reservists sailed into action. Soon the entire eastern seaboard was dotted with private yachts and power boats of auxiliary and reserve members. Each vessel's registration numbers began with "CGR." With machine guns visible on the bow and stern, they became known as the "Putt-Putt Navy," "Splinter Fleet" and "Corsair Fleet." Although commanded by reservists or Coast Guardsmen, reservists often manned their guns. Although the Auxiliary did not sink any U-boats, they did help to keep shipping lanes free and the United States' coast safe.

Other Auxiliarists patrolled the shores on horseback, others on bikes, walking or in cars. Others sat upon hills overlooking the water, for anything out of place. They observed the oceans, lakes, rivers, bridges and railway lines — any place a saboteur could cause a problem.

During World War II, the Auxiliary began wearing uniforms and developed a working relationship with the active duty Coast Guard . Today, no matter what the Auxiliary is involved in, they are e a part of Team Coast Guard. Auxiliarists reach out to their communities and support the men and women who serve in the Coast Guard. They try to make a difference.
