 - Social media: Our website is up-to-date.
 - Fall RBS training courses (Boat America, Sailing Skills and Seamanship) have been posted to social media as well as direct announcements sent to the West End Boat club and Corinthian Yacht Club.
 - OPERATIONS: OP Ramer

 - Chris Sheetz performed 7 vessel examines. These were performed at the Cape May Marina and Commodore Bay Marina in Avalon, NJ. Six (6) vessels got stickers.

- PUBLIC EDUCATION: PE Anderson
 - Dates have firmed up for teaching the Coast Guard Sailing Certification class (9/21 11/16) @Creutzburg Center and Boat America class (10/25 11/15) @ Lower Merion High School. Five (5) signed up for Sailing course Meade/Bayard will be instructing. Four (4) people signed up for Boat America course so far.
 - Jan Munroe is leading committee to conceptualize using PE opportunities for the purposes of member recruitment (Committee: Munroe, Anderson, Zambrana, Bowden).

3. Develop curriculum for an additional 'non-Coast Guard approved' course to be offered to boaters on the Northern Section of the Chesapeake Bay – Anderson/Bowden

4. Explore opportunities to expand PE sessions outside the Main Line Night School program. For example, offer boating safety classes to High School Boating Clubs in the Main Line area – Zambrana

5. Expand advertising of Main Line Flotilla course offerings through billeting boards at boat supply/dealership stores – Bowden

6. Bring back "Suddenly in Command" course (Added)
