# AVIATION (John Perritt):

John Perritt and Dan Meigs joined other members of SEC.NC AUXAIR at Cherry Point MCAS on Saturday the 11<sup>th</sup>, for our annual Swim Qualification. This basically involves a 50 yd swim around pylons, climbing into a floating (aircraft) Raft, assisting subsequent members into the raft and egressing the raft to a simulated rescue vessel. At the conclusion, the Staff at the Rescue and Survival facility provided a tour and discussed their training of Marine Corp aviators.

Below is a screen shot of a portion of the Ohio River. The green and red lines are point-to-point flying routes between the odd-side and even-side ATONs. The WPTs for the route are read directly from the Light List file provided by NAVCEN. This capability will allow aircraft to fly a precision GPS route, with their ForeFlight NAV system, and the observers can see the exact location of the aircraft and the next WPT (ATON) on the other side of the river. Because the rivers are (relatively) narrow compared to coastal estuaries and Bays, there is no need to create separate Flight routes offset from the line of sight for the two WPT routes.

The DSO-NS in D8(er) has provide the Google Earth file for the entire district to 116 CX. They are evaluating the GE file as a current LL reference source.



## CM (Herman Franke):

The FSO-CM participated in two High Frequency nets during the month. Reception conditions were terrible with a high level of atmospheric noise. A station in the net transmitted a digital message, but it could not be received here due to the noise interference.

The FSO-CM did not participate in the January VHF division radio net,
