## **Recent Activities:**

- 10-1 Presented the Goals & Objectives for PA at our first FSO meeting February 1st. Included a digital presentation.

10-5 Contacts were made with Brunswick County's largest employers (hospitals, Nuclear Plant, ADM Plant, Sunny Point) concerning the possibility of distributing our boating safety calendar to their employees in their internal newsletters. Only ADM took the information.

10-5 Sent photos of past boating safety classes for inclusion with media stories about our upcoming classes. State Port Pilot included the photo.
