- ALWAYS request Assignment to Duty. This is very important.
- Check the USCG website for Beacon Alerts. You will find safety related and recall related information.
- Use and distribute the new Kayak Reflector Kit. They are becoming very popular. You can order these using #3004B and can order 50 at a time.

I want to remind all Vessel Examiners that we are in the business of educating our boating public. We want all Vessel Safety Checks to stress as quality and not so much quantity.

Remember, We are Educators first and Decal Stickers second.
