The Boat Crew Academy has started on March 22nd. There are five dates left at Station Chincoteague.

Chincoteague Detachment Report: Mark Wrightstone:



First Aid: Training is scheduled for Saturday, March 22, 2025, all are invited to attend.



U.S. Coast Guard Cooperation: BM1 Meyer of the Chincoteague station advised that there is an active terrorist threat to the 100th annual Pony Swim that takes place July 30-31, 2025. He informed us that there will be an increase of law enforcement visible on the island. BM1 Meyer also asked us about the possibility of having additional vessels available for the Pony

Swim. Warren Peake has volunteered his vessel.

BM1 Meyer has volunteered to offer the Detachment suspicious vessel identification training so that Auxiliary can be better aware during the Pony Swim and report any suspicious activity to active U.S. Coast Guard members.



Public Relations: June 17 is Coast Guard Auxiliary Night at the Museum of Chincoteague. Several members of the Detachment and the Coast Guard will be on hand to offer information, answer questions and recruit future members.

We discussed having members set up a table at local Farmers Markets in Chincoteague and Captains Cove for public information. The Farmers Markets begin in approximately 7 weeks.

It was decided that we would enter a float in the 100th Pony Swim parade. We will use a boat as the float.

We also discussed the need for future vessel examinations in Captains Cove, Chincoteague Town Dock and Curtis Merritt Harbor in Chincoteague.

Training: VE training and Boating Safety training. Warren volunteered to check about getting some training materials.

Warren also said that he would check about getting materials for Knot Tying demonstrations for the parade and Museum outreach. Members continue to work on online Auxiliary training and will attend the upcoming Boat Crew Academy at U.S.C.G. Station Chincoteague.
