Minutes of the General Meeting U.S.C.G. Station Ocean City 5 MAY 2025



Visitor: Glenn Duffy VFC determined there was a quorum.


A motion was made to accept the March 2025 minutes by Barry Cohen and seconded by Steve Haffner. The motion carried.

TRAINING OPPORTUNITIES AND NOTIFICATIONS:

Planned monthly training meetings at the library are replaced by monthly meetings 90 minutes prior to monthly Flotilla meetings.

Through the summer, meetings will continue to focus on familiarization with AUXDATA II, Moodle Classroom, and Certifications.

Fifty-four (54) patrons visited out table including 8 children


