
The monthly meeting of flotilla 12-05 was called to order by Bob Sheehan FC via an inperson and a virtual Zoom call

Auxiliary Core Training (AUXCT)

Auxiliary Core Training (AUXCT) is a series of training courses focused on sup Coast Guard Auxiliarists' assignment and performance of duties. The Coast Guar required to ensure that its Auxiliarists are appropriately trained, tested, and four competent before being assigned to duty. The course selection is a minimum bar organizational familiarity and expectation supporting this goal. The value of this has formed the core of every Auxiliarist's pledge and commitment to support the Guard and abide by its governing policies.

AUXCT contains a series of courses that members must take as a one-time requiupon joining the Auxiliary or re-certify once every five years.
