So far this year, our flotillas have reported 375.1 hours of operational time related to aids to navigation and marine patrols. With the weather warming and hopefully drying, we are ramping up these activities.

Operational support to the Coast Guard (Watchstanding and Food Service) has accounted for 351.7 hours so far this year.

054-20-04 New Bern, Oriental AOR

There will not be any watchstanders for the next 3 months. The one Qualified person will be in D1 Station Southwest Harbor where he is also a qualified watchstander.. This situation demonstrates the need to proactively enlist members to this opportunity.

Unfortunately our ability to support the station with FS personal seems to fall short of the need. As with Watchstanders, we need to develop more FS personal. We were unable to support several requests for assistance.

The flotilla has been requested by Station Hobucken to extend their operational season. To this end the flotilla has received several new mustangs. We are awaiting SAR vests to go with them. We expect to get three more months on the water. This year we are limiting cold operations to 201204 as it is a closed cabin vessel.

20-10 member Collins has developed an asset with side scan sonar which is very effective in searching for submerged drowning victims. Local EMS & FD do not have submerged search capability. This has the potential to be a very useful service to the community.

Increase the number of certified PVs in the Division by at least 5.

There have been several new members in Division Flotillas this year. I have asked each FSO-PV to encourage them to get their PV Certification. Working towards gaining a net of 5 or more in 2019.

Increase the number of visits in 2019 above 2018 level of 1,210.

Ongoing efforts to keep this pace. With our current reported performance a bit behind 2018. I am confident that we will pick up the pace once May and June reporting is in. Approximately at 83% of last year's PV's but reporting generally lags 1-2 months.
