2. Hurricane Florence forced drastic changes in the saliently of the waters in the Trent/Neuse river basin which will affect the breeding areas if shrimp, fish and shellfish.

3. State is "starting to look at" current regulations for ponds at hog and chicken farms in hopes another massive release of the ponds holdings which caused the beaches to be closed.
