# **<u>Celebrating New Space for Auxiliary Activities</u>**

#### Joshua Murray Boating Safety and Awareness Initiative at Blythe Landing Dedicated



On 18 May 2024, family and friends of Joshua Murray, local law enforcement officers, members of the Coast Guard Auxiliary and the boating public gathered at Blythe Landing in the town of Cornelius in Mecklenburg County, North Carolina, for the dedication of the *Joshua Murray Boating Safety and Awareness Initiative*. Old-timers will remember this building as a lakeside commissary. The building has now been turned into a vibrant resource for providing boating safety information, a classroom for teaching boating safety education, and a space for providing radio guard while Division 26 auxiliarists and marine police units are on patrol on Lake Norman.

The Boating and Safety and Awareness Initiative is established in honor of Joshua Murray, a Cornelius police officer who passed away from a massive pulmonary embolism while off duty. Officer Murray was known to be an excellent law enforcement officer with a big heart. Boating safety was his mission in life and establishment of this initiative is a step forward in continuing that mission. Another force behind this initiative is an increased awareness of the need for boating safety awareness and education following multiple drownings on Lake Norman in recent years.

The space will be shared by law enforcement officers, members of the Coast Guard Auxiliary, the Lake Norman Marine Commission, and several other local organizations committed to fostering a safe boating environment and providing boating safety education. Before entering into this partnership, a memorandum of understanding (MOU) was established between Mecklenburg County, North Carolina, and the US Coast Guard Auxiliary for the purpose of collaborating on initiatives to promote safe boating practices. Members of Division 054-26 are in the process of establishing a radio station at Blythe Landing. The new tower will enable watch standers to contact the far reaches of Lake Norman.

Dave Wascher, 26-01; Mark Briggs and Rick Croasdale, 29-02; and Darrin Sanchez, 26-01 conducted multiple two-boat towing drills in order to meet yearly currency requirements to maintain boat crew qualification and to increase proficiency. An added goal was to practice optimizing professionalism when serving the public and when training new auxiliary members.











# **Removal of Hazards to Navigation**

On the morning of 7 June 2024, members of Division 26 embarked on a maritime observation patrol on Lake Wylie in South Carolina. On OPFAC 21952 was Rick Croasdale, Flotilla 26-02, as coxswain and Darrin Sanchez, Flotilla 26-03, as crew. David Washer, Flotilla 26-01, joined the patrol with his personal water craft (PWC), OPFAC 10849. It turned out that the mission was very productive in making Lake Wylie a safer waterway.

During the patrol, the vessels encountered multiple hazards to safe navigation and were able to

intervene and dispose of problematic items safely.

While on his PWC, Auxiliarist Wascher was able to secure a line to a large piece of wood and remove it from the lake. The wood was deposited on the boat ramp at Charlotte Fire Station 38.







While motoring in the same vicinity a misplaced "No Wake" buoy was located on the shore of a cove. The buoy appeared to be one that was missing from the area near where a bridge passes over the cove on Shopton Road West. The buoy appeared to be at least a quarter of a mile out of position. The buoy was also towed to the boat ramp at Fire Station 38.

The third and last item that was discovered during the June 7th patrol was a 30 foot section of a tree floating in the middle of Lake Wylie. David Wascher was able to secure a line to the tree and tow it to shore. The auxiliarists on this patrol managed to make navigation on Lake Wylie much safer. This was a mission that made a difference.





## **Auxiliary Joins Law Enforcement Exercise**

On 8 April 2024 several members of Division 26 participated in a Law Enforcement Exercise spearheaded by the Cornelius Police Department (CPD) on Lake Norman, North Carolina. Additional marine units joined from Lincoln, Catawba and Iredell Counties. Gary Eifried, John Dibbins, and Sydney Newcombe from Flotilla 26-04 and Mark Briggs from Flotilla 26-02 participated as boat crew and Allen James, Flotilla 26-04, provided radio guard.

This year, the exercise focused on the response to medical trauma emergencies on the lake. The exercise began with an excellent presentation by a member of the CPD emphasizing emergency casualty care with emphasis on boating accidents. Stations were established that focused on broken bones, penetrating wounds, and

propeller contact wounds.

The morning air temperature was chilly, but the water temperature was just above 60 degrees, making Mustang suits unnecessary. Over the course of the morning, coxswain Gary Eifried, with crewmember, Mark Briggs, provided a safety zone with OPFAC 22724 for an event in which first responders required divers in

the water. John Dibbins and Sydney Newcombe were called upon to role play trauma victims in need of assistance.

Auxiliary members were able to conduct navigation training drills during the law enforcement exercise and while enroute to home dock. The area of Lake Norman that was traversed was Ramsey Creek in Cornelius, and Blythe Landing in Huntersville, North Carolina. Participating in these exercises helps to solidify the relationship between members of the law enforcement units on Lake Norman and auxiliarists. Both have the same mission: saving lives through boating safety missions and education.

# Law Enforcement Calls on Auxiliary for Assistance

#### **Search for Drowning Victim**

Early in the morning on Friday, 5 July 2024, a call was sent out by Cornelius Police Department for help with keeping boaters away from a search scene on Lake Norman, North Carolina. The day before, on the busy July 4th holiday, a swimmer had entered the water, did not surface, and rescue units were unable to find the swimmer. Coxswain Gary Eifried rose to the occasion, obtained orders from Coast Guard Station Elizabeth City, recruited John Dibbins as crew and Sharon Eifried as radio guard and set off in OPFAC 22724 to assist with screening as search teams looked for the drowning victim. It was essential to try to keep recreational boaters not only from entering the area, but try to limit boaters stirring the waters which hampers the effectiveness of the sonar.

Additionally, Sharon Eifried broadcast a SECURITE message on Chanel 16 every 30 minutes, requesting all boaters to avoid the sandbar at Day Marker D4 on Lake Norman. On Saturday, Gary Eifried broadcast a SECURITE message every 30 minutes during the day. Using SONAR equipment, the search team finally located the body of the victim at 2330 on Saturday. It was a sad day, a life lost, a lesson learned too late. Thank you to the first responders and to those that strive to get out the boating safety message.



### **Dragon Boat Race on Lake Norman**

# **Cub Scouts Learn About Boating Safety**

On 1 May, 2024, members of Flotilla 26-04 traveled to Huntersville, North Carolina to present a boating safety class to Cub Scout Pack 222. Thirty scouts rotated between one station focused on proper wearing of life jackets and a second station focused on what is necessary to be safe on a boat. Following consultation with the scout leaders, the following scouting topics were included in the class content.

- 1. Show how to safely help someone who needs assistance in the water, without having to enter the water yourself.
- 2. Identify five different types of boats.
- 3. Show that you can put on and fasten a life jacket correctly
- 4. Explain the safety rules that you need to follow before participating in swimming or boating.
- 5. Explain the importance of response personnel or lifeguards in a swimming area. Tell how the buddy system works and why it is important.
- 6. Explain the safety rules that you need to follow before participating in boating.
- 7. Identify the safety equipment needed when going boating.
- 8. Show how to do both a reach rescue and a throw rescue.

Auxiliarists John Dibbins, Gary and Sharon Eifried, Hap James, Sydney Newcombe, Jarrett and Pierre Rheeder, and Scott Wigginton interacted with scouts, parents, and leaders while teaching and assisting scouts to try on life jackets and handle safety equipment. The scouts were very enthusiastic, responding positively to the invitation to participate. Parents were attentive, asked questions, and verbalized appreciation for the class. Once again, auxiliarists were in the community, making a difference while completing the mission of providing boating safety education.

#### 2. d- Compass North.

While a compass naturally points to magnetic north, a boat compass experiences additional deviation from the electronics and metal on the boat, which must be taken into account.

#### 3. **d- 5.**

The Coast Guard District 5 (or Fifth District) consists of the states of Delaware, Maryland, Virginia, North Carolina, the District of Columbia, and parts of New Jersey and Pennsylvania.

#### 4. a, b, and c.

Inflatable PFDs cannot be worn on a jet ski. They also cannot be worn by children under 17, or when water skiing.

5. Although it's clearly not required, I would salute the Commodore as a sign of respect. According to the U.S. Coast Guard Auxiliary, saluting is not required between Auxiliary members. However, saluting is a way to show respect and appreciation for the time and effort that Auxiliary members volunteer. Saluting is also proper when greeting members of the Armed Forces, including officers of the National Oceanic and Atmospheric Administration (NOAA) and the U.S. Public Health Service (USPHS).

6. **b. False.** Jet skis cannot be used between sunset and sunrise, even if equipped with after-market navigation lights.

D26 has 6 Flotillas: 26-01: Lake Norman, 26-02: Lake Wylie, 26-03: Davidson,
26-04: Lake Norman West, 26-05: NC Western Foothills (Lake Hickory), 26-07-Badin Lake.

8. Lake Wylie is partially in North Carolina, partially in South Carolina. This makes it a lake under USCG jurisdiction.
