District 7 Quarterly Report

Unit/AOR/Program Area: Flotilla 22

1. Current Progress Relative to District Operations Plan and Contingency Plans:

Flotilla 22 continues to ramp up its Boating Safety Program, Vessel Examinations, Program
Visits and Lake Allatoona Patrols, as the weather permits.

2. Accomplishments in Recruiting and Retention:

- We continue to Recruit members during Vessel Examinations, Boat Shows. At this time, we have one new member in the pipeline (application submitted) and two others still in the exploratory stages. District approves the cutting of Prospective Candidates after two months, rather than letting nonresponsive candidates linger in the system.
- Personal phone calls to members who have not attended meetings in a while, and engage them on what can the Auxiliary do to motivate attendance and where are the areas they would like to make an impact.

3. Program/Department Activities, Events, Projects, and Performance:

- Public Affairs
 - a. Cabela's Open House February 8th & 9th
 - b. 3 Boating Safety Class signups
 - c. 3 Vessel Examination signups
 - d. 1- Flotilla Interest
 - e. Total of 30 direct "meaningful" interactions at the event
 - Flotilla 22 National Safe Boating Week (NSBW) committee established.
 - Attended and instituted new program of tracking Prospective Auxiliary Candidates in Flotilla and Division.

4. Problems, Issues, Concerns and Suggested Solutions

- The number of qualified radio operators has been a drain on the number of watch standers that are available. There are six qualified, but only two available for operations.
- Only 50% of the membership attend meetings. Increase membership awareness in supporting Flotilla events.
- Will continue to recruit members to take part in Public Affairs Events accomplish by utilizing emails and phone calls to members.

5. Action Items:

Institution of New Membership Program tracking. D7 to follow the methodology of other
Districts in allowing HR rep to insert information into a real time data base. This will cut
the need to forward e-responder spreadsheets to the District.

Flotilla 25 was again at the **Upstate South Carolina Boat Show**, January 23-26, following a 4-year absence. The show at the Greenville

Convention Center was full and no vendor booths were available, but the event coordinator provided a large space for our booth at an intersection in the large boat dealer area. Thanks to Immediate Past Flotilla Commander (IPFC) Larry Cole for arranging.

The Flotilla meeting was held February 22, both in person at the Galley Restaurant, Upper Deck at Portman Marina and online. Our thanks to Flotilla 29 for the use of their Zoom account. The annual Program Visitor workshop was presented following the meeting, still in person and online. Nearly 24% of the membership in person and nearly 37% combined attendance. The Flotilla 29 Zoom was also used to present the Risk Management/Team Coordination (RM/TCT) workshop on February 19-20, with members of both Flotillas 25 and 29 attending.

The first Public Education (PE) **Boat America** class was held on March 1 for 11 students, ranging in age from 12 to grandparents. All were sign-ups from the Upstate South Carolina Boat Show with most attendees from Georgia, including from Buford, Brazelton and Gainesville. We are working to have the Georgia attendees registered for class attendance in the GA DNR student database. Will research doing the same thing for the South Carolina attendees.

We had an additional public affairs opportunity on March 1 with an invitation to attend the Western Carolina Sail Club annual Blessing of the Fleet. Following the public education class, we were able to represent the Flotilla and CG Auxiliary, and enjoy their Low Country Boil. The next public affairs event will be a table at the Lake Hartwell Association annual meeting at the Anderson Civic Center, expecting hundreds of members in attendance and at another meeting location in Hartwell, GA. This will be followed on March 15 by the Lavonia Boat Show, where the city will close 2 blocks of Main St for local boat dealers, other businesses, and civic groups. Last year, the booth was next to the Hartwell VFW and the Lake Hartwell Association (LHA), which resulted in a new member and a closer relationship with the LHA.



This resulted in the latter opening use of the Hart County Library Education Center for the PE classes and representation at other civic functions.

For Operations, the Flotilla has two Facilities and 3 operations qualified members, 2 Coxswains and 1 boat crew. We also have 3 non-current crew and 6 members interested in crew qualification. We will be scheduling the RM/TCT and Operations workshops for this and planning patrols, when

available, for needed currency maintenance and underway hours. The first patrol event on Lake Hartwell will be the Greenville Health System annual **Dragon Boat Race**, this year on Saturday May 3rd. We will need Division assistance with crew and would appreciate having another Facility.

The Flotilla's March meeting is being moved to the 5th Saturday in March due to CG Auxiliary functions at Flotilla or Division on every other Saturday. Following the meeting, we will present the annual Vessel Examination (**VE**) workshop for member training. The Risk Management, Operations and Telecommunications workshops will be presented online.

From the standpoint of Division 2, the AUXSCOUT program is active.

First, we have been matching the few Sea Scout Ships in the area covered by our Division with existing Flotillas. Augusta and south-central Georgia have some opportunities as both Flotillas and Ships start their own rebuilding programs. As each unit progresses in their own rebuilding, it is hoped they will get more involved with each other. The Atlanta area is definitely involved in an active Ship.

The simplest way for any Flotilla to be involved with a Sea Scout Ship is to offer to provide a Boat America Course to them. The Sea Scouts have a provision in their own advancement that requires the Scouts to take an approved boating safety course from an approved organization. We qualify.

There are two major challenges for the AUXSCOUT program. The obvious for us in Division 2 is we have Flotillas that are in a rebuilding stage. Age catches up with all of us, and as a Division, we are going through that. The second challenge is, in a way, tied to the age issue. Many members just simply feel they do not want to work with "kids." The fact is these are eager youngsters who are bright and capable. They want to learn, and they want to participate. We have found that these youngsters are an added bonus on patrol, as they can do some of the jobs that our aging bodies can't do as well anymore. Yes, they can go on patrol — as guests, but that doesn't mean you can't train them and use them.

I have taken on the role of SO-CA this year, and would like to thank **Rob George**, SO-CA in 2024, for his guidance and help in getting me up to speed. The Culinary Assistant program within the Auxiliary appears to be a vibrant component that is generating a lot of

interest on both the "Silver" and "Gold" sides. Opportunities exist to serve the active side at both shore stations and aboard cutters. Here in Division 2, the closest Coast Guard location is **Station Tybee**, located near Savannah, Georgia. So far this year, there have been three new AUXCA1 candidates that have been certified to serve with the Coast Guard, with at least two more in the pipeline to become qualified. There are two types of certifications for this program, namely **AUXCA1** and **AUXCA2**. The former indicates a candidate has gone through the extensive classroom and on-site training at a Coast Guard location that has a Galley, and in which PQS signoffs have been completed by Coast Guard personnel. An AUXCA2 certification is less strenuous in training, and indicates that culinary assistance may only be provided at the Auxiliary level, and not at a Coast Guard facility. This level is also automatically grandfathered in with the AUXCA1 certification.

Listed below is a breakdown of the current classifications of AUXCA by Flotilla within our Division:

Two-way radio communications are not just a convenient way to talk to each other, but it has become a necessity for emergencies. A properly installed and maintained VHF marine radio has now become almost a must. Whether it is a handheld, marine mobile, mobile or fixed station, your device needs to be frequently checked

and maintained. Major items that should be watched and checked for are grounding and bonding, SWR, incoming voltage, output power, condition and placement of the antenna.

It is also important as to where and how the radio is installed. If there is enough interest, I would be happy to host a TCO qualification training or TCO workshop, or even training for Technician level amateur radio operators license for the Division. I would be glad to personally check any Division member's radio in person if they would prefer to do it on an individual basis.

Also, please don't forget we will need radio operators for the Army Ranger drop that is coming up soon.



DDSL Report

As of this writing, we have 221 Members in our Division. We added a new Member to Flotilla 25, in January, and have one Application pending from Flotilla 22. In 2024, the Applications averaged 32 days for processing.

In March of 2023, I reported on a new Citizenship Verifier Qualification Process. As you might expect, the process has changed for 2025. Below are the steps to becoming a Citizenship Verifier.

Steps for Becoming a Citizenship Verifier

- 1. Complete ICS-100 and ICS-700 FEMA courses.
 - (https://training.fema.gov/ndemu/schools/emergency-management-institute).
- 2. Review the Fingerprint Technician Manual located at:
 - (https://drive.google.com/file/d/1miXWbhKYqrmNRzcslVx1m3e5_BgNpBHY/view)
- Successfully complete the FPRINTTECH exam in the National Testing Center. (https://ntc.cgaux.org).
- 4. Submit a Help Desk ticket using the "Certification Submission Other". Add the following text in the message box:

"I have completed reading the Fingerprint Training materials and successfully passed the Fingerprint Exam in NTC. Please waive the fingerprint card portion of the qualification as fingerprint cards are not required for application to the Auxiliary. I am requesting certification as a Citizenship Verifier only.

Very Respectfully,"

Your Full Name and EMPLID

5. Verify that your CV certification appears in AUXDATA. This may take up to two weeks to process.

In addition to the above steps, you will need to have a current Uniform Inspection.

Who should become a Citizenship Verifier? Anyone in the Flotilla involved with the processing of New Member Applications, such as the FC, VFC and FSO-HR.

There is only one new member in this quarter, with 20 Prospective Candidates in the pipeline. The District has given all HR Officers the following guidance:

- 1. Access to the Prospective Member Management System. In the past we were required to track members through the e-responder system, an excel spreadsheet which was cumbersome to manage.
- 2. Now HR members with the requisite training can go into AAMS and update real time the status and contacts with Prospective Candidates.
- 3. E-Responders can still be maintained, but no need to provide to District.
- 4. It is recommended if a Prospective Candidate has been non-responsive for two months, we are authorized to make a recommendation for their removal from the system.
- 5. All walk-ins or self-generated candidates will be only tracked within the Flotilla. They will not be entered in the electronic system.

So far this year, less than 50 members have reported 3,712 hours for 2025. Where are the rest of you? You are responsible for reporting what you do, whether you or your FSO-IS does the entry.

AuxData II is the perfect source to keep track of all of your activities and status. Recent changes have made it very easy to be sure you are up to date on everything. Do not rely on anyone else to keep you on track, learn to do it for yourself.

An opportunity to become more familiar with what areas you can explore and utilize will be made available at the **S TRAIN** offered on March 22. I've heard people remark that "no one told me", but only YOU are responsible for asking for help or taking advantage when training in offered.

At the beginning of the year, 441 people in District 7 lost all of their Competencies just because they didn't complete their Uniform Status updates before 12/31/2024. Core Training expiration will also cause all of your Competencies to go into REYR. **DON'T LET THAT HAPPEN**. If you choose to no longer maintain a Competency, there is a form for submission to remove the Competency.

With over 200 people in the Division, if you need help, reach out to the Officers responsible for that area. Member Training, Operations, Program Visitation, Vessel Examinations and Information Services are some of the general categories.

Let's get started on this early in the year, and make it work for all of us.

For those members not familiar with what is handled by the Auxiliary National Supply Center (ANSC), the catalog is on the national web site (www.cgaux.org) under the "Auxiliary Members" tab and the sub-tab is

"Auxiliary Manuals". When that page comes up, it is the green notebook on the extreme right. If there are any questions about what you can or cannot get, please contact me.

For other items, such as uniforms and accessories, there is the store on the Coast Guard Auxiliary Association's web site (www.cgaux.org — or via the direct link on the Auxiliary web site under the next to last tab on the right). If you are looking for small items like ribbon bars or some uniform items that might be in your Flotilla store (if applicable), check with your FSO-MA officer first to see that is the case before placing an order on the web site. This can probably save you some money if the item is in your Flotilla store. The Association's web site has changed over the years, so if you have not visited it recently, please do so. There is a sub-tab on the Auxiliary site that will take you to the store, of if you go to the Association's Home Page, click on "MORE" and that will ultimately take you to the store.

As an FYI, for those of you who might want to wear a pin on civilian clothes that indicate the highest office you have achieved in the Auxiliary, there is a pin indicated on the first page of the Uniform (All Items) tab that shows the DCO/ANACO pin. It would go on a sport or suit jacket. I don't think they show the other levels, but I know the store has them. Contac me with any questions if you are interested. According to the site, they have reduced prices on a lot of items. I know they are trying to reduce their inventory on a lot of things, many of which will not be reordered. Contact me if there is something you cannot find, but which you thought should have been there, as I can find out if it is still available. You can place your orders directly with the store, and accept credit cards for purchasing items.

Did you know that a Uniform Inspection is now mandatory? In early January of 2025, more than 400 Auxiliary Members in D7 went REYR for Core Training because they did not have a Uniform Inspection

recorded in AuxData II. In our Division, we still have 22 members in this state. To make matters worse, when you go REYR for Core Training, you also go REYR for any Competency you have!

Did you know that we have 112 Members (50.6%) in the Division that still need to take their **Suicide Prevention Course** before the end of this year? Of the 112, 43.7 percent or 49 Members have at least one Competency that could go REYR at the same time. Are you REYR in a Competency where you do not plan to get your Currency back? Why not submit a request to remove the Competency from your records, rather than waiting five years for National to remove the Competency.

In January, we had two training sessions for Suicide Prevention, where 26 Division Members were certified for the course. Watch your email for additional Zoom classes to be held throughout 2025.

Previously, we have published a patrol roster by Flotilla, updated weekly so all could know when patrols were scheduled for training, currency or participation. This was easier with the previous AUXDATA system which had a calendar of patrols by Facility and order status. I would appreciate if FSO-OPs could provide an update of your Flotilla's missions, but am expecting to also find a process for accessing this information in AuxData II.

Likely expected events needing multi-Flotilla support include:

- Army Ranger Airdrop on Lake Lanier, expected for May 6 and 7 with backup day May 8.
- Lake Hartwell Dragon Boat Races, expect May 10.
- All lakes: Boating Safety Week-Operation DryWater June 28-July 6 (July 4 week).
- Possible Sector Charleston support
- Lake Jocassee-Greenville Health System Emergency Training with SC ARNG Air Support late August

Please let me know if you have an event that needs additional support.

The main operations event this quarter has been Division-wide reporting of personal protective equipment (**PPE**) requirements for this year. A primary requirement is replacement of Personal Locator Beacons (**PLBs**) needed because of expiring batteries. Thank you to all Flotilla Operations officers for their timely reporting.

While we wait for patrol weather and order funding, training is our primary need. This is the time for the required annual **Operations** and **Risk Management** workshops. In-person workshops will be conducted at several Flotillas, and the Risk Management workshop will be presented twice at the Division **S-Train** event on 22 March. A Risk Management (**RM**) workshop was presented online and attended by members of Flotillas 25 and 29. Several more RM and the Operations workshops will be offered online so that everyone needing these for currency or new qualification will have the opportunity to atten.

Thanks for all that you do. I look forward to talking, seeing and working with you.

Mr. AMATO is cited for meritorious service in the performance of duty as Boat Crew Coxswain on 04 July 2024. In support of the Lake Lanier Water Safety Task Force, Mr. AMATO demonstrated outstanding operational skill in the rescue of three inexperienced boaters in the water with an overturned jet ski. As the evening sun started to set and the lake traffic increased for the fireworks show, the crew of the Auxiliary Facility "Early Out" was alerted to an emergency on Lake Lanier. As the only Coast Guard asset on the lake, Mr. AMATO was instrumental in the search and rescue. Mr. AMATO spotted the operator and passengers clinging to the partially submerged jet ski and prepared the deck for recovery of the boaters. After the coxswain positioned the facility for pick-up, Mr. AMATO retrieved the distressed boaters from the water and along with another crewmember performed an injury assessment and provided first aid. One of the passengers was in the early stages of shock after being in the water for more than half an hour. Mr. AMATO immediately contacted emergency response while the crew tended to the passenger. Once the passenger recovered and was no longer in danger, the crew placed the jet ski in tow and returned the family back to their dock. Mr. AMATO's judgment and devotion to duty are most heartily commended and are in keeping with the highest traditions of the United States Coast Guard and the United States Coast Guard Auxiliary.


